## **Report of the Head of Legal and Democratic Services**

### **1. LICENSING ACT 2003 – APPLICATION FOR A PREMISES LICENCE – TREBANOS RFC, TREBANOS, SWANSEA, SA8 4BN**

The Sub Committee was asked to consider an application for a Premises Licence for the Trebanos RFC, Trebanos, Swansea, SA8 4BN. The circulated report contained details of the application under the Licensing Act 2003.

The Licensing Manager informed Members that the premises currently holds a club premises certificate authorising licensable activities in accordance with those applied for in the application. However, the applicant proposed to change the nature of the business from a members club to a public house as contained in the circulated report.

The Sub Committee noted the views of the Environmental Health Section as set out in Appendix 2 of the circulated report that entertainment noise at the premises shall be inaudible inside any noise sensitive property. The Licensing Manager advised that the applicant had agreed to the inaudibility clause as a licence condition and on this basis the Environmental Health Officer had now withdrawn his representations.

2. **LICENSING ACT 2003 – APPLICATION FOR A PREMISES LICENCE – BUTCHERS ARMS, ALLTWEN HILL, ALLTWEN, PONTARDAWE, SA8 3BP**

The Sub Committee was asked to consider an application for a Premises Licence for the Butchers Arms, Alltwen Hill, Alltwen, Pontardawe. The circulated report contained details of the application submitted under the Licensing Act 2003.

The Licensing Manager advised Members that the condition contained in Paragraph 2.5 of the circulated report, recommended by the Environmental Health Officer with regards to the premises should now read:

“that the external patio area should not be used after 22.30 hours”.

The Sub Committee noted that the applicant had agreed to the revised additional condition above and on this basis the Environmental Health Officer had now withdrawn his representations.
