Items shown on the plan which are not required by the plans regulations are for administrative purposes only and do not form part of the licence. These

items may be moved at the discretion of the premises licence holder or DPS. The current location of the fire safety equipment and other equipment is also shown on the plan, items may be moved following a fire risk assessment.

No live music is to be provided after 2300 hours unless the applicant obtains an acoustic report from a suitably qualified acoustics engineer and implements any works necessary to the satisfaction of Environmental Health.

Any recorded music provided after 2300 hours is to be at a background level only to be agreed with Environmental Health.

The Protection of Children from Harm

No unaccompanied children will be permitted on the premises

A proof of age scheme will operate requiring persons to provide recognised photographic identification as required.

Any conditions necessary to promote the prevention of public nuisance should be tailored to the style and characteristics of the specific premises. Licensing authorities should be aware of the need to avoid unnecessary or disproportionate measures that could deter events that are valuable to the community, such as live music. Noise limiters, for example, are very expensive to purchase and install and are likely to be a considerable burden for smaller venues.

3.2 Notice

The premises currently has a premises licence authorising the sale of alcohol on Friday and Saturday evening until 00.00 hours and recorded music until 23.00 hours.

The Temporary Event Notice is to extend the hours for sale of alcohol and regulated entertainment on Friday and Saturday nights until 0130 hours. The premises user has submitted eight temporary event notices to cover Friday and Saturday nights. The first notice is proposed to take effect on the weekend of the 8th August 2008 and continue for every weekend until the weekend of the 26th September.

3.3 **Background Information**

A Temporary Event notice must be served on the Licensing Autority and the Police. Only the Police can object to this notice and only on the grounds that it will undermine the crime prevention objective.

3.4 Objection Notice

An objection notice has been lodged by the Police and is reproduced at appendix 3

3.5 Policy Considerations

Licensing Policy

Crime and Disorder

- 6.2 The Council acknowledges that licensed premises, especially those offering late night/early morning entertainment, alcohol and refreshment for large numbers of people, can be a significant source of crime and disorder problems. The Council expects the licensing trade to fully co-operate and play its part in minimising crime and disorder.
- objectives, it also has a duty under Section 17 of the Crime and Disorder Act 1998 to do all it reasonably can to prevent crime and disorder in the County Borough. The Council is required therefore to have particular regard to the likely impact of licensing on crime and disorder. The nature or type of premises, its location, the hours of operation, its impact on the area, the operation and management of premises are all significant factors, which can impact on crime and disorder. All applications for licences or certificates including renewals and variations will be expected to have addressed these matters within the operating schedule

3.6 Officer Report

The purpose of the hearing is to consider the objection notice lodged by the Police in respect of eight temporary event notices given by the premises user/designated premises supervisor.

After hearing representations from the premises user and the Police, members are required to decide whether to give the premises user a counter notice if they consider it necessary for the promotion of the crime prevention objective. The issue of a counter notice means that the temporary events notices become invalid and the proposed extended hours for sale of alcohol and provision of regulated entertainment cannot go ahead.

3.7 Recommendation

That members determine whether to issue a counter notice.

In the recent Upper Neath Valley Partnerships and Communities Acting Together (PACT) meeting held in the Glynneath area. Residents have complained about Anti-Social Behaviour at High Street, Glynneath and problems with persons drinking and being rowdy outside the public houses fronting onto High Street, Glynneath.

Cont'd

The Glynneath Neighbourhood Police Team monitored the situation and as a result of their observations concerning the Crown Inn I wrote to you on the 11th June 2008 (See Appendix A).

The Neighbourhood Officers have continued to monitor licensed premises in the area and it would appear the above-referred applicant and licensed premises are carrying out un-authorised licensable activities in contravention of Section 136 of the Licensing Act 2003:

The unauthorised licensable activities observed are as follows:

At approximately 01:20 hours on Sunday 22nd June 2008 officers visited the licensed premises and upon their approach could hear loud music emanating from inside.

The officers entered the front door of the premises and saw in the region of 60 to 70 persons' drinking, playing pool and socializing. The interior lights were on and loud music was playing from a sound system. The officers observed alcohol being served at the bar and the transaction and money being put through a till.

The officers spoke to the Designated Premises Supervisor Mr Hughes and a female person who they believe is his wife and asked to inspect the summary of their licence.

The licence was placed over the bar and stated that permitted hours of sales of alcohol were until midnight.

Cont'd

The officers informed Mr Hughes that he was in breach of his licence by being open to members of the public at this time and by continuing to sell alcohol an hour and twenty minutes past his licence.

At approximately 00:15 hours on Saturday 19th July 2008 Glynneath Neighbourhood Officers observed 19 persons inside the premises consuming alcohol, the till was on and the side door of the premises was open.

At approximately 00:30 hours on Sunday 20th July 2008 Glynneath Neighbourhood Officers noted that the front door of the premises was wide open and persons entering the licensed premises, there was also a number of revellers outside the premises.

The officers spoke to the applicant Mr John Luther Hughes and he was reminded that his licence only entitled him to serve alcohol until 00:30 hours. The officers informed him that they would be returning to the area later and patrolled to the Resolven area.

At approximately 01:05 hours later that same day and date the officers returned to the Crown Inn Public House where they noted a male person who was clearly intoxicated enter the premises via the open front door.

At this time music was being played excessively loud inside the premises and the noise could clearly be heard from a considerable distance at High Street, Glynneath.

The officers entered the premises via the open front door and saw that alcohol was still being served and the till was active and that approximately 50 - 60 persons were inside the premises with no person giving the impression they were leaving.

Cont'd

The officers were then approached by Mrs Hughes who began to ask the officers why they were being targeted at that time of the night and stating that it was the only chance to make any money.

The officers pointed out the requirements of the premises licence to Mrs Hughes but she remained adamant that they were struggling and they could not turn away good trade. The officers informed her that she was putting her licence in jeopardy at which point she flew into a rage and told the officer he did not know the village and she knew best.

Mrs Hughes later shouted at the officers "OH FUCK OFF".

In their conversation with Mrs Hughes the officers noted that she appeared to have been drinking as her words were slightly slurred, she was non cooperative and was unwilling to see what she was condoning was contrary to the terms of her licence. The above occurrences show that the presence and behaviour of some of these

persons whilst congregating outside and leaving the premises continues to cause fear

and intimidation to residents and other members of the public using High Street,

Glynneath.

It is respectfully suggested that the above clearly indicates the Licence Holder,

Designated Premises Supervisor (Mr Hughes) and his wife are blatantly contravening

Section 136 of the Licensing Act 2003.

In addition to the above the Police feel that in permitting this type activity and

behaviour the License Holder and the Designated Premises Supervisor are clearly not

promoting the licensing objectives namely:

- the prevention of crime and disorder;

public safety;

- the prevention of public nuisance; and

the protection of children from harm.

It is envisaged that during the summer holiday period there will be an increase in

persons visiting and congregating in the local pubs that are open the longest further

contributing to further Anti-Social Behaviour, disorder and nuisance.

The above information is submitted for your perusal and consideration.

Unauthorised licensable activities. Contrary to Section 136 of the Licensing Act 2003.

In the recent Upper Neath Valley Partnerships and Communities Acting Together (PACT) meeting held in the Glynneath area. Residents have complained about anti social behaviour at High Street, Glynneath and problems with persons drinking and being rowdy outside the public houses.

The Glynneath Neighbourhood Police Team is monitoring the situation and it would appear the above-referred Licensed Premises is carrying out unauthorised licensable activities in contravention of Section 136 of the Licensing Act 2003:

The unauthorised licensable activities appear to be taking place mainly on Friday evenings, Saturday and Sunday afternoons and evenings and being carried out as follows:

Persons are purchasing alcohol inside the premises and are going outside the front of the premises and are congregating in large numbers drinking from glasses and bottles and in doing so are obstructing the adjacent pavements and even spilling out onto the road way. The presence and behaviour of some of these persons are causing fear and intimidation to residents and other members of the public using High Street, Glynneath.

APPENDIX A

This activity clearly indicates the Licence Holder is using the public highway (High Street, Glynneath) at the front of the premises as an extension of the licensed premises and as a result is contravening Section 136 of the Licensing Act 2003.

In addition to the above it is felt that in permitting this type activity and behaviour the License Holder is clearly not promoting the licensing objectives namely:

- the prevention of crime and disorder;
- public safety;
- the prevention of public nuisance; and
- the protection of children from harm.

I am Police Sergeant 3471 Ridd of the South Wales Police currently based at Glynneath Police Station with the Neath and Dulais Valley Neighbourhood Policing Team.

At 01:20 hours on Sunday 22nd June 2008 I was on full uniformed duty in company with Police Constable 4762 Jenkins. At this time we alighted from our police vehicle at the junction of Lancaster Close with High Street to conduct a licensing visit at The Crown Public House which is positioned on this junction. Upon exiting the vehicle I could hear loud music emanating from inside The Crown. PC Jenkins and I walked to the front of the premises where I could see that the curtains were drawn across the windows and the front door was open. PC Jenkins and I entered the premises where around the bar area I saw in the region of 60 to 70 persons drinking, playing pool and socializing. The interior lights were on and loud music was playing from a sound system. I observed alcohol being served at the bar and the transaction and money being put through a till.

I spoke to the licensee John Hughes and a female person who I believe is his

wife and asked to inspect the summary of their license. The license was placed over the bar and stated that permitted hours of sales of alcohol were until midnight. I informed the licensee that he was in breach of his license by being open to members of the public at this time and by continuing to sell alcohol an hour and twenty minutes past his licence.

Mr. and Mrs Hughes replied by stating that this was the only time that they do any real business and could I look the other way. Mr. Hughes then added that he heard a lot of things and would be willingly to provide information if they were allowed to continue. I informed them that would be submitting a report of what I had observed to the Licensing Officer.

At 01:10 hours on Saturday 19th July 2008 I was on full uniformed duty in company with Police Constable 4762 Jenkins. At this time we attended outside The Crown Public House with the intention of conducting a licensing visit. The front door was closed and the curtains drawn across the two ground floor windows which though through gaps light could be seen inside. The side door situated in Lancaster Close was closed also. Suspecting that there were licensing breaches occurring inside I tried the side door and it opened without resistance. I turned left from the door and entered the bar area where I counted 20 persons of drinking age consuming alcohol and playing pool. There was no music playing but the till was on and displayed three numbers on the LCD screen. There were three persons leaning against the bar with pints in front of them.

I informed the landlady Mrs. Hughes that she was breaching her licence by being still open for business and she replied that her customers were going to leave shortly.

At 00:30 hours on Sunday 20th July 2008 I was on full uniformed duty in company with Police Constable 4762 Jenkins on static observations in a marked police vehicle at the junction with Gellidawel Road and High Street. From this position which faces The Crown Public House I could see that there were approximately a dozen persons outside sitting on the benches drinking alcohol. I also observed the front door to the public house was open and could hear loud music blaring into the street from inside. I saw a man stagger across the High Street and enter The Crown through the open door.

PC Jenkins and I alighted from the police vehicle in order to speak to a male

person sitting at one of the benches about an unrelated matter. Whilst speaking to the man PC Jenkins and I were approached by the licensee John Hughes. I finished speaking to the man and joined PC Jenkins in speaking with John Hughes. PC Jenkins pointed out to Hughes that his licence only allowed him to have customers on his premises until at the latest half past twelve and that he needed stop serving alcohol and start shutting the pub. Hughes responded by saying that he was doing any harm and then asked us not to be so awkward. PC Jenkins then told Hughes that we were going to Resolven and on our return would be checking his establishment again.

At 01:05 hours PC Jenkins and I returned to outside of The Crown Public House where I saw a male person in a pale blue denim jacket who was clearly inebriated by the manner in which he walked enter through the open front door of The Crown.

PC Jenkins and I entered through the same door and I observed approximately 50 to 60 persons inside drinking alcohol, listening to the loud music and playing pool. Alcohol was being served at the bar and I observed three transactions in which money was received and passed through the till.

As we stood at the doorway observing this we were approached by the landlady who said to the pair of us,

"Why are you targeting us all the time?"

I replied,

"Because you are regularly breaching the terms of your licence."

The landlady then said,

"But this is the only time we get to make any money."

I replied,

"That is not my concern if you need to stay open later go through the proper channels and apply for extended hours. Right now you are acting irresponsibly and basically are running an after hours club. You are going to lose your licence if you carry on like this."

The landlady retorted,

"You haven't had any complaints have you, you don't know what's best for the village we been doing this for 13 years I know the village."

The landlady appeared slightly drunk and I can evidence this by the fact that she was slurring her words, that her eyes were glazed and that her breath

smelled of alcohol. The landlady became angry and stared shouting in a scornful manner into the pub,

"The sergeant says you've got to go, the Sergeant says you've got to go. Everyone out the Sergeants closing the pub."

I felt that her attitude and demeanour were irresponsible and could have incited trouble. PC Jenkins and I decided that it was best to leave and as we walked away I looked over my shoulder and saw and heard the Landlady shout from about 10 yards away,

"Oh fuck off."
