Any conditions necessary to promote the prevention of public nuisance should be tailored to the style and characteristics of premises and the type of activities expected to take place there.
- 7.42 As with all conditions, it will be clear that conditions relating to noise nuisance may in certain circumstances not be necessary where the provisions of the Environmental Protection Act 1990 and of the Noise Act 1996 adequately protect those living in the vicinity of the premises in question. But as stated earlier in this Guidance, the approach of licensing authorities and responsible authorities should be one of prevention and when their powers are engaged, licensing authorities should be aware of the fact that other legislation may not adequately cover concerns raised in relevant representations and additional conditions may be necessary.
- 7.43 Where applications have given rise to representations, any necessary and appropriate conditions should normally focus on the most sensitive periods. For example, music noise from premises usually occurs from mid-evening until either late evening or early morning when residents in adjacent properties may be attempting to go to sleep or are sleeping. In certain circumstances, conditions relating to noise may also prove necessary to address any disturbance anticipated as customers enter and leave the premises and therefore, in the immediate vicinity of the premises.

1.8. Officer's Report

The police representations refer solely to prevention of public nuisance and make recommendations to minimise problems.

Similarly the environmental health officer expresses concerns at the proposal to provide live music and suggests restrictions and

conditions to address this issue.

Residents make representations about noise, social disturbance and anti-social behaviour. All these matters should be considered along with any submissions from the applicant.

1.13. Background Information

Purpose built sports and social club adjoining extensive playing fields and sports areas situated at Groes, Margam, Port Talbot with on site car parking, access from public highway known as Abbots Close, Margam, Port Talbot.

1.14. Promotion of Licensing Objectives

The following information has been provided by the applicant:

The Prevention of Crime & Disorder:

The CCTV monitor is located behind the main bar at first floor level.

All club employees are instructed not to admit or serve members or guests who behave in a disorderly or durnken fashion.

Public Safety:

The club complies with health and safety and fire precaution requirements

The Club complies with capacity limits as indicated by the Fire Authority. Fire action notices are exhibited and all emergency escape routes are sign posted and there is an emergency lighting system.

Drinks may be consumed on the ground floor and first floor balconies but not elsewhere on the sports field.

Drinks for consumption on the balconies are only supplied in plastic receptacles.

Notices are posted at the door leading to the balconies prohibiting glass ware being taken on to balconies.

The Prevention of Public Nuisance:

Display sign near exits requesting members and guests to respect the

needs of residents by leaving both premises and car park quietly. The amplified sound system on the premises is controlled from a control panel behind the bar.

Stewardess and bar staff to control volume to avoid disturbance by sound.

The Protection of Children from Harm:

The rules do permit children between the ages of 7 yrs and 18 yrs to be admitted to the premises only with permission and provided accompanied by a responsible person.

First floor concert hall is made available for persons under the age of 18 years from time to time. However the bars are closed and only non alcoholic drinks may be consumed.

Signage is posted prohibing the direct or indirect supply or delivery of alcohol to children.

Provided by applicant:-

Long established detached public house at London Row, Cwmavon, Port Talbot with on site car park and beer garden.

1.33. Promotion of Licensing Objectives

The following information has been provided by the applicant:

General - all four licensing objectives:

We run a Public House as a husband and wife team, with assistance from family members. There is a single bar supplying lounge, bar and pool room, and for off sales, and for consumption at the beer garden and we are in a position to view all arrivals and departures. We are aware of the objectives of the Licensing Act 2003 and of the statutory requirement upon us to comply with all relevant provisions of that Act.

The Prevention of Crime & Disorder:

We do not permit drunkeness or disorderly conduct and will have no hesitation in requiring patrons who are either drunk or disorderly to leave the premises, and will invite the Police to assist if there are any difficulties.

Public Safety:

We are aware of the health, safety and fire precaution requirements. We have fire fighting equipment and emergency lighting, and there is a street light immediately outside the property, and an external security light on the garage at the property.

The Prevention of Public Nuisance:

We are aware of the location of the property at the end of a terrace of residential units including an Old People's Home, and live on the premises ourselves and always encourage patrons to leave both premises and car park quietly. If any live, recorded, music or karaoke is in use, we take steps to ensure that there is no disturbance to neighbouring residents.

The Protection of Children from Harm:

Persons under the age of 18 years are only permitted to be in the beer garden of the premises when accompanied by parents and we and our staff are well aware of the prohibition on providing directly or indirectly any alcohol for consumption by children. We require proof of age in respect of anyone who in our opinion might not have attained the age of 18 years.

It is considered that the following policies are relevant to this application:

Statement of Licensing Policy

6.0 Crime & Disorder

6.6 In addition to the requirements that the Council promote the licensing objectives, it also has a duty under Section 17 of the Crime and Disorder Act 1998 to do all it reasonably can to prevent crime and disorder in the County Borough. The council is required therefore to have particular regard to the likely impact of licensing on crime and disorder. The nature or type of premises, its location, the hours of operation, its impact on the area, the operation and management of premises are all significant factors, which can

impact on crime and disorder. All applications for licences or certificates including renewals and variations will be expected to have addressed these matters within the operating schedule.

6.9 The Council considers that certain types of premises are likely to require additional measures or conditions due to the nature, type and mode of operation. These would include premises, which sell alcohol and cater mainly for the 16-25 age group and provide regulated entertainment, or premises which provide events or entertainment mainly for children.

In order to ensure the safety of patrons and other persons in the vicinity of the premises, the council suggests that operating schedules give consideration to the following measures and may require any or all of these measures to be implemented in the interests of minimising crime and disorder.

(ii) CCTV

The provision of CCTV is a very useful tool in monitoring premises to assist in ensuring the safety of patrons and preventing crime and disorder. The council may specify that a suitable system approved by the police and council, covering the interior and exterior of the premises, is installed. This should be properly maintained and fully operational whilst the premises are open. The areas to be covered should normally be entrances, both external and internal and any part of the premises not routinely under visual supervision including beer gardens. CCTV tapes should be kept for twenty-eight days and made available to the police and local authority officers at any time.

2.4. Background Information

Provided by applicant.

Premises are a single storey building of brick and wooden construction with a flat roof. There are 2 bars and a separate lounge/hall.

2.5. Promotion of Licensing Objectives

The following information has been provided by the applicant:

General - all four licensing objectives:

Any person whose behaviour falls below the unexpected standard will be reported to the committee with the intention of dealing appropriately with that person and maintaining standards. All staff will be trained as to their responsibilities under the Licensing Act, especially regarding under age sale, and sales to intoxicated persons.

Responsible sales promotions such as two for one or pay for entry all you can drink for free will not be undertaken.

The premises will be open for 30 minutes after the last sale of alcohol, to allow a period for what is now referred to as drinking up time.

Beyond the time when alcohol sales are permitted, no person will be allowed to remove alcohol from the premises, and off-sales will not be permitted.

The Prevention of Crime & Disorder:

The premises is only used by members and their bona fide guests. Areas of the premises are supervised by bar staff from the servery areas and by members of the Committee around the premises themselves.

The Club has a discipline policy, and any members whose behaviour falls below the required level will be brought before the Committee and may be suspended or excluded from the Club. Any illegal activity will be reported to the Police and the fullest of co-operation will be given by committee and staff.

A committee person will be on duty at the premises whenever licensable activities are undertaken.

To ensure gaming machines are in such a position that they can be supervised by staff.

All staff will request a proof of age identification from any person who appears to be under the age of eighteen years who attempts to purchase or consume intoxicants.

There will be a regular collection of glasses and bottles.

The right to search any member or guest will be a condition of entry to the premises.

Public Safety:

The premises will comply with the requirements of the Fire Authority at any given time, in respect of procedure and equipment.

All safety equipment will be regularly tested, and a log will be kept of such tests for inspection.

Patrons of the premises are mainly of an older age group.

The premises will have fire safety equipment as per the requirements of the Fire Authority, and all fire exits will be properly maintained, free from obstructions and marked in accordance with current best practice.

A regular risk assessment will be undertaken in respect of safety issues, and all staff will be instructed on safety and evacuation procedures in the event of an incident.

In the event of an incident, staff will cease all activities at the premises to supervise any whole or partial evacuation.

All fire and safety systems will be regularly tested, and a record of those tests will be kept on the premises for inspection.

Plastic drinking vessels will be used by persons at the outside drinking areas.

The Prevention of Public Nuisance:

During the time of any musical entertainment, doors and windows will be kept closed to minimise noise pollution.

Members and their guests will be reminded to be respectful of neighbours whilst leaving the premises, particularly late at night.

Bottling up and waste disposal will not be carried out at the close of business, but the following day.

Any person whose behaviour is below the required standard will be

requested to leave, if necessary with the assistance of the Police.

It will not be permitted to remove glass vessels from the premises, nor to remove alcohol from the premises beyond the time when alcohol is permitted to be sold. Any off sales will be in closed vessels.

The premises will be open to members and bona fide guests for a period of thirty minutes after the cessation of the last licensable activity.

The Protection of Children from Harm:

Children will be admitted to the premises, those under the age of 14 years must be accompanied by a responsible adult. A range of non-alcoholic drinks will be available for any young persons in the premises. Children will only be permitted during any film or entertainment in accordance with any age restriction on that film or entertainment.

Proof of age will be required from any person who appears to be under the age of 18 years.

Proof of age will be by photographic drivers licence, passport or other official photographic I.D.

either late evening or early morning when residents in adjacent properties may be attempting to go to sleep or are sleeping. In certain circumstances, conditions relating to noise may also prove necessary to address any disturbance anticipated as customers enter and leave the premises and therefore, in the immediate vicinity of the premises.

2.8. Officer's Report

The environmental health officer refers to existing problems with noise at the premises, and makes recommendations in relation to hours of operation and conditions.

Residents make representations with regard to noise from music, social disturbance, anti-social behaviour and car parking.

These representations should be considered after hearing any personal representations, and also any submissions from the applicant.

Premises are a single storey property with a main hall, lounge and lounge bar, a games room, dining/meeting room, trophy bar and two kitchens.

2.14. Promotion of Licensing Objectives

The following information has been provided by the applicant:

General - all four licensing objectives:

Any person whose behaviour falls below the expected standard will be reported to the Committee with the intention of dealing appropriately with that person and maintaining standards. All staff will be trained as to their responsibilities under the Licensing Act, especially irresponsible sales promotions such as two for one or pay for entry all you can drink for free will not be undertaken.

The premises will be open to the public for 30 minutes after the last sale of alcohol to allow a period for what is now referred to as drinking up time.

Beyond the time when alcohol sales are permitted, no person will be allowed to remove alcohol from the premises and off sales will not be permitted.

The Prevention of Crime & Disorder:

The premises is only used by members and bona fide guests. Areas of the premises are supervised by bar staff from the servery areas and by members of the Committee around the premises themselves.

The Club has a discipline policy, and any members whose behaviour falls below the required level will be brought before the Committee and may be suspended or excluded from the Club. Any illegal activity will be reported to the Police and the fullest of co-operation will be given by Committee and staff.

A Committee person will be on duty at the premises whenever licensable activities are undertaken.

To ensure gaming machines are in such a position that they can be supervised by staff.

All staff will request a proof of age identification from any person who appears to be under the age of eighteen years who attempts to purchase or consume intoxicants.

There will be a regular collection of glasses and bottles.

The right to search any member or guest will be a condition of entry to the premises.

Public Safety:

The premises will comply with the requirements of the Fire Authority at any given time, in respect of procedure and equipment.

All safety equipment will be regularly tested, and a log will be kept of such tests for inspection.

Patrons of the premises are mainly of an older age group.

The premises will have fire safety equipment as per the requirements of the Fire Authority, and all fire exits will be properly maintained, free from obstruction and marked in accordance with current best practice.

It will not be permitted to remove glass vessels from the premises, nor to remove alcohol from the premises beyond the time when alcohol is permitted to be sold. Any off sales will be in closed vessels.
