Report of the Head of Legal Services

1. **LICENSING ACT 2003 – TRANSITIONAL PREMISES LICENCE
APPLICATIONS – TYN Y TWR TAVERN, TYN Y TWR ROAD,
BAGLAN, PORT TALBOT, WEST GLAMORGAN**

The Sub Committee was asked to consider the licence applications for the variation of a Transitional Premises Licence for the above mentioned premises. The applicants, Mr. and Mrs. Nicholls, along with their legal representative, Mr.Hussell, attended the meeting in support of the application. Also present were persons who had submitted objections to the variation application.

(a) Variation Application

The circulated report contained details of the application for the variation of a premises license during the transitional period under Schedule 8 of the Licensing Act 2003.

In accordance with the prescribed procedure the Sub Committee heard representations from the applicants and questioned all parties concerned. The circulated report contained details of information provided by the applicants relating to the promotion of the four licensing objectives.

The circulated report also contained details of written representations received from the responsible Authorities and Interested Parties. Personal representations were made by residents in the vicinity of the premises. The Sub Committee was informed that, due to amendments made to the application, the representations from the Police Authority had been withdrawn.

The Sub Committee adjourned following receipt of all representations prior to reaching the final decision.
