## **Report of the Head of Legal and Democratic Services**

1. **LICENSING ACT 2003 – APPLICATION FOR A PREMISES LICENCE – THE BEEZ KNEEZ, 104 WINDSOR ROAD, NEATH, SA11 1DY**

The Sub Committee was asked to consider an application for a Premises Licence for the Beez Kneez, 104 Windsor Road, Neath, SA11 1DY. The circulated report contained details of the application under the Licensing Act 2003. The applicant, Mr. Kai Tin Choi, was not in attendance.

The Licensing Manager outlined the details of the application and explained that the premises was formerly known as The Oxford Arms and that this application relates to the ground floor only of this two storey premises, which would be separated into take-away and restaurant areas. The Sub Committee noted the views of the Environmental Health Section as set out in Appendix 1 (points 1 and 2) of the circulated report in respect of:-

- (i) entertainment noise to be inaudible;
- (ii) offer by the applicant to keep all windows and doors closed when amplified music is being played.

The Licensing Manager advised that:-

- (a) the Applicant had agreed to the inaudibility clause as a licence condition and on this basis the Environmental Health Officer would withdraw his representations.
- (b) in respect of point 2 of Appendix 1 of the circulated report – this was already a part of the operating schedule and would automatically be attached as a condition and was therefore not an issue.

**RESOLVED:** that the above application be granted subject to the additional condition outlined below and other conditions consistent with the operating schedule which would be confirmed in writing to the applicant:-
