Mr.J.Sullivan, Licensing Manager, informed Members that the premises had been licensed in the past under the former business known as Tobins. Mr. Sullivan confirmed therefore that this application was a new application and not linked at all with any previously held licenses. He also informed the Sub Committee that the area to be licensed would be at the ground floor level only, as indicated on the Plan tabled at the meeting.

2. <u>APPLICATION FOR A SUMMARY REVIEW OF A PREMISES</u> <u>LICENCE – JIMMY'S BAR, 33 STATION ROAD, PORT</u> <u>TALBOT, SA13 1NN</u>

Mr.J.Sullivan, Licensing Manager, gave an overview of the grounds regarding the application for a Summary Review to the Sub Committee as detailed in the circulated report. He also reminded the Sub Committee of the decision made at the meeting held on the 21st May 2009, where interim steps were taken to suspend the licence. Mr. Sullivan also informed the Sub Committee that Mr.J.Hall, the licence holder, had not exercised his right to make representations following the decision of that meeting.

Two of the licence holders Mr. J. Hall and Mrs.M.Hall along with the manager, Ms M. McCook, attended the meeting. They were represented by Mr.J.Hussell, Solicitor, and Mr.G.Jones, Counsel.

After hearing all relevant representations the Sub Committee adjourned to make their decision.

effect.
