Report of the Head of Legal and Democratic Services

1. **LICENSING ACT 2003 – LICENSING ACT 2003 (HEARINGS)
REGULATION 2005 – APPLICATION FOR A VARIATION OF
PREMISES LICENCE – THE OTHER PLACE, 9 YNYSDERW
ROAD, PONTARDAWE**

The Sub Committee was asked to consider an application for a variation to an existing Premises Licence for the above mentioned premises.

At the start of the meeting the Licensing Officer circulated street plans and premises layout plans of The Other Place, to all present at the meeting, allowing sufficient time for Members to read.

The Licensing Officer updated the Sub Committee on the background of the application and explained that the requested variations were as set out in the circulated report, and could be summarised as follows:-

To extend the sale of alcohol for two hours at the start of the day from 10.00 to 08.00, to extend it by two hours at the end of the day on Sundays through to Thursdays from 23.00 to 01.00 and to extend it by one hour on Fridays and Saturdays from 00.00 to 01.00.

The Sub Committee noted that there were no representations from Responsible Authorities, although the Police and Environmental Health submitted observations which were not objections to the application for variations. There had been 13 letters of objection and 7 letters of support received, which were contained as appendices within the circulated report.

After listening to all parties concerned, the Sub Committee adjourned to make its decision.
