Report of the Licensing Manager

1. **LICENSING ACT 2003 APPLICATION FOR A PREMISES
LICENCE – BRYNDULAIS HOTEL, SEVEN SISTERS**

The Sub Committee was asked to consider the application for a premises licence for the Bryndulais Hotel, Seven Sisters.

The Sub Committee received representatives of the Police Authority, the Environmental Health Section and the Licensing Manager. The applicant Mr G.Lewis, together with Mr K.Gould, also attended the meeting.

The Sub Committee was informed that, although written representations had been received from 5 local residents as detailed in the circulated report, no local residents were able to attend the meeting.

The Licensing Manager then outlined the application. The Sub Committee was informed that, due to informal discussions held prior to the meeting, the hours of the application had now been reduced as outlined at the meeting.

The applicant indicated that he accepted the revised hours as outlined to the Sub Committee. Consequently the Police Authority representative now wished to withdraw his objections. The Environmental Health representative indicated that the only condition now requested referred to noise being inaudible within relevant properties situated adjacent to the application premises.

In accordance with the prescribed procedure, the Sub Committee then heard representations from the applicant.

Following summing up by all the parties, the Chairman indicated that, in their absence, the written submissions received from the local residents would also be taken into account when reaching a final decision.

The Sub Committee adjourned following receipt of all representations prior to reaching its final decision.
