- The premises licence holder must: Provide and maintain a CCTV System which is operational at all times when the premises is open to the public. The system must provide coverage of the following areas:
- a) The external perimeter of the premises;
- b) The entrances and exits to the premises;
- c) The interior public areas of the premises; in particular those areas that cannot be observed from the bar servery.

The CCTV tapes must be retained for a period of 28 days and made available for viewing by the Police or an authorised Officer of the Licensing Authority on request.

- All drinking vessels used on the premises should be of toughened glass or plastic.
- No open glasses or bottles should be brought into or out of the premises by customers.
- A documented procedure must be in place to verify the age of persons who appear to be under eighteen years of age to prevent them gaining access to the premises and or purchasing alcohol. The means of verification should be restricted to:-
 - (1) Accredited Proof of Age Scheme's e.g Portman, Validate
 - (2) Photocard driving licence or passport.
- Transferred Conditions:
- Public Entertainment Licence

- 1. Permitted Numbers Ground Floor 200 First Floor 500
- 2. No entry/re-entry two hours before the last permitted hours.
- 3. The applicant to liaise with residents to ensure noise levels are reduced to a minimum.
- 4. That the nightclub entrance only is used after 11.00pm

1.3. Background Information

The premises consists of a bar to the ground floor and a nightclub to the first floor. Each floor is accessed via separate entrances.

1.4. Grounds for Review

That if the premises are allowed to continue to operate as information received suggests it has done so over the previous 12 months it would not promote the licensing objectives namely: the prevention of crime and disorder; public safety; the prevention of public nuisance; the protection of children from harm.

Further details as provided by the applicant are referred to as appendices a, b and c on the application and are produced at appendix 1.

1.5. <u>Further Representations</u>

When a review is submitted, all responsible authorities and interested parties are also able to make representations. No representations have been received by any of the responsible authorities. Five further representations have been received from interested parties i.e. residents in the vicinity of the premises in support of the application for review by the Police. These representations are produced at appendix 2.

1.6 Licensing Officer's Report

An application for the conversion of the existing licence for the Arch nightclub was granted in November 2005, thus the existing operating hours for the sale of alcohol and provision of regulated entertainment were retained.

A previous application for review of the licence was considered by members in January 2008 when it was decided that no action be taken.

The current application was first considered by this Sub-Committee in January 2009 when after hearing all the evidence members resolved that they modify the conditions of the licence, but that the police and premises licence holder be given an opportunity to agree conditions based on the police requirements set out in this report. The matter is then to be referred back to this Sub-Committee for finalising the licence conditions.

Members will be aware that the premises were closed at the time of the review and are still closed, however it is possible that they may be reopened in the near future.

Proposed conditions for the premises are set out in Appendix 4 for consideration.

1.7 Recommendation

That Members finalise the conditions to be attached to the premises licence.

I am one of ten siblings and my twin sister Elizabeth Coleman aged 49 years lives next door but one to me at Commercial Street, Neath in the County Borough of Neath and Port Talbot.

In the year 2000 a Nightclub Premises called "Signals Night Club" but also known as the "Dark Arch" and "Bar Metro" located opposite and near to my home at Commercial Street, Neath, opened its doors to the public providing late night entertainment to members of the public.

Since that time and date, I my sister and other residents at Commercial Street. Neath have been subjected to countless and varied forms of noise nuisance, incidents of serious disturbance, assaults, some against Police Officers and littering, verbal abuse and threats and damage. The persons responsible for all theses occurrences are patrons of the above-referred Nightclub Premises.

Much of the regular noise nuisance and disturbance we have been subjected to is as a result of the female manager of the premises Debra Richards openly flouting the Licensing Laws and routinely allowing the premises to either remain open outside the permitted Licensing hours or opening the premises up outside such hours to allow the premises to be used as an "All Night Drinking Establishment".

This behaviour has resulted in the premises being allowed to remain open most weekends throughout the night until around 05:30 hours and on one occasion 06:50 hours.

I have made numerous complaints about the lawless activities being committed outside the premises and near to my home to the Police and Local Authority Licensing Department.

As a result around December 2007 and January 2008 the Neath Port Talbot County Borough Council Licensing Department and Police Licensing Officer instigated on my behalf a Review of the Night Club Premises, which was heard by the Licensing Committee.

The Review application failed which I believe was because there were no Police records made available to the Licensing Committee to support my concerns.

The complainants allege that the regular noise nuisance and disturbance they have been subjected to is as a result of the above named female manager of the premises openly flouting the Licensing Laws and routinely allowing the premises to either remain open outside the permitted Licensing hours or opening the premises up outside such hours to allow the premises to be used as an "All Night Drinking Establishment".

On Sunday 13th July 2008 Mr Coleman's complained that the premises opened late for a Poker night event.

That the lights inside the premises being switched off and people were being allowed into the premises when it should be closed.

On Sunday 3rd August 2008 Mr Coleman's complained the premises opened until late in the night.

At approximately 01:45 hours Sunday 10th August 2008 Mr Coleman's complained that "Mels cabs" dropped off Debra Richards and other persons off outside the Nightclub premises and they opened the premises up.

At approximately 03:39 hours on Sunday 10th August 2008 occurrence number 62080281382 relates to Miss Elizabeth Coleman's complaint that persons were engaged in rowdy behaviour outside the Nightclub Premises at Commercial Street, Neath.

At approximately 05:00 hours on Sunday 17th August 2008 Mr Coleman's complaint that he saw Debra Richards leaving the premises.

At approximately 00:40 hours on Monday 25th August 2008 Mr Coleman's complained there was a fight outside the premises.

At approximately 01:22 hours on Saturday 13th September 2008 occurrence number 62080321164 relates to Mr Coleman's complaint that continual "Lock in" drinking session taking place at the Nightclub premises.

Mr Coleman's complains that since making his statement to the Police the premises has continued opening to the public outside its permitted hours over the weekends.

The complainants state that the premises opened on Friday evening 10th October 2008 and remained open throughout the entire weekend until well into the morning of Monday 13th October 2008.

In addition to the above referred occurrences it is suspected Mr Coleman made numerous other reported occurrences but declined on those occasions to provide his name and address.

The complainants also reported to the Police unrelated matters which occurred in Commercial Street, Neath and the Police have recorded these occurrences.

Mr Coleman is able to produce numerous posters, letters and even a CD disc which has been posted through the letter box of the front door of his home relating to the advertised activities at the above-referred Nightclub premises, which can be produce as exhibits if so required by the Licensing Committee.

Both complainants are prepared to attend Court and or Licensing Committee to give evidence in this matter if required to do so. They have made Section 9 witness statements which are attached and they are agreeable to any interested third party having access to or a copy of this statement served on them.

In their Victims' Personal Statement Scheme they would like to point out to the decision makers the following:

That the activities of Debra Richards, her staff and the behaviour of the patrons of the Nightclub premises have caused them and other residents at Commercial Street, Neath, considerable anxiety, alarm and distress.

They state their quality of life has been affected by the continual noise, light nuisance and numerous drunkenness related incidents of disturbance and violence which have resulted in numerous persons receiving injuries and becoming distressed which we have also had to witness which has added to their distress.

They continue by stating that there are regularly discarded and smashed bottles in the roadway and on the pavements outside the Nightclub premises and their homes. That person have urinated over and into their properties, vomited, discarded rubbish caused vandalism outside our properties and caused alarm and distress to them by shouting threats, abuse and banging on the windows and doors of their properties.

The Premises License Holder, Designated Premises Supervisor and suitably trained staff to fully participate in the Neath Port Talbot Business Crime Retail Partnership (BCRP), Pub Watch and Nite-Net radio Schemes and attendance at such meetings to be mandatory under the conditions' of the Licence.
- 6. The Premises Licence Holders, Designated Premises Supervisors shall take all steps reasonably practicable to prevent a noise nuisance to any Neighbouring properties, with no noise to be heard inside the nearest noise sensitive premises during hours of operation, during sound checks prior to commencement of the entertainment and as patrons leave the Premises.
- The Premises Licence Holders, Designated Premises Supervisor shall display prominent, clear and legible notices at all exits requesting patrons to respect the needs of local residents and to leave the premises and the area quietly.
- A Proof of age policy to the satisfaction of South Wales Police Community Safety Department and the Neath Port Talbot County Borough Trading Standards Department will be in place (Challenge 21).
- 9. The Premises CCTV system will be a digital system, upgraded and operated and maintained in conjunction with and advice and the reasonable recommendations and requirements of the Police Licensing and Divisional Crime Prevention Officers, including image retention and retrieval requirements for 31 days. With duty staff adequately trained in its use at all times the premises are operating during permitted hours. The system to be operated at all times that the premises are open to the public. CCTV Cameras to cover all public areas (excluding toilets), including the exterior of the premises (Front and Rear), any queues, areas where door supervisors stand (To protect them from false allegations) front and emergency exits.
- An Anti Drug policy to the satisfaction of and agreed by the Police Community Safety Department and Local Authority will be in Force.

- All patrons will be subject to random searches as a condition of entry into the Premises.
- 14. The Premises will promote a drug safe environment.
- 15. The Premises Licence Holder, Designated Premises Supervisor under the terms of the Licensing Conditions will assist and accommodate Police, Local Authority Joint Agency operations and initiatives in the promotion of a drug safe environment and the licensing objectives.
- 16. The variation of the premises will not increase in any risk to public safety.
- The premises will operate an incident reporting system which will be readily available for Police and Local Authority inspection.
- The premises will operate a duty staff and security personnel duty log which will be readily available for Police and Local Authority inspection.
- 19. All door supervisor / Security Staff to be registered with the Security Industry Agency (SIA) and whilst on duty at the premises be in possession of a current and valid (SIA) authorisation card which will be readily available for Police and Local Authority inspection.
- The maximum permitted numbers on the premises will remain at the same levels for the ground and first floor.
- A Counter system will remain in place to monitor and ensure the maximum numbers of the premises are not exceeded in each area of the premises i.e. ground and first floor.

I have to report that Senior Police Officers at Force and Divisional Command Team level and supported by rank and file officers from within the Neath Port Talbot Division, have serious concerns about late night alcohol related violence and incidents' of Public Order Anti-Social Behaviour.

This is a concern echoed throughout the Country and highlighted recently in the National Media.

It is respectfully pointed out that when comparison is made between the above occurrences recorded against the premises with residential population of more densely populated areas within Neath and Port Talbot area. The occurrences recorded at Commercial Street, Neath are unacceptably high.

This negatively impacts on the complainants, other local, residents, and Commercial Premises in the area and affects the general perception of the Commercial Street area of Neath.


I am aware the premises have temporarily closed but its licence is still in force and information has been received the premises will reopen in December 2008 for the Christmas period.

Arch Bar & Nightclub Commercial Street Neath

- 1) The premises licence holder shall actively participate in the Neath Port Talbot Business Crime Reduction Partnership (BCRP) Pubwatch and Nite Net radio schemes and the premises licence holder or a representative shall attend all meetings of BCRP and Pubwatch. additional condition
- 2) Prominent, clear and legible notices shall be displayed at all exits requesting patrons to respect the needs of local residents and leave the premises and the area quietly. additional condition
- 3) The Challenge 25 proof of age or similar scheme as agreed with the police shall be operated at all times whilst the premises are open to the public. replaces existing condition
- 4) A digital CCTV system is to be implemented in accordance with best practice and the requirements of the police. The system shall provide coverage for all public areas and exits (both internally and externally). Images must be retained for a minimum of 31 days, and the system must be operational at all times when the premises are open to the public. All relevant staff must be properly trained in the use of the CCTV to ensure that these requirements can be met.

 Recordings shall be made available immediately on request by police or authorised officer of the licensing authority. replaces existing condition
- 5) An anti drugs policy agreed with the police must be implemented and in operation at all times whilst the premises are open to the public. The log shall record the date and time of the incident, the personnel involved and reporting the incident, action taken and where appropriate the outcome of the incident. This must be kept available for inspection by the police and the licensing authority at all reasonable times. — additional condition

- 9) The premises licence holder will provide and maintain a register of all door supervisors operating at the premises. This shall contain the name, address and licence number of each person carrying out security duties as well as the date and time commenced, and time completed his/her duties and shall be signed by the door supervisor. The register shall be available for inspection on demand by the police or authorised officer of the licensing authority. additional condition
- 10) The premises licence holder shall operate and maintain a counting system to monitor the number of persons entering and exiting the premises to ensure that maximum numbers are not exceeded. additional condition
