Report of the Licensing Manager

1. <u>LICENSING ACT 2003 - APPLICATION FOR A PREMISES</u> <u>LICENCE – THE EXETER INN, 52 BRITON FERRY ROAD,</u> <u>NEATH</u>

The Sub Committee was asked to consider an application for a premises licence for the Exeter Inn, 52 Briton Ferry Road, Neath. Members noted that the Applicant was applying for a new licence as he intended to include an adjoining property into the existing premises. The circulated report contained details of the application under the Licensing Act 2003.

The Applicant Mr. J. Griffiths who was the Landlord of the Exeter Inn and his advisor Mr. B. Allen, were in attendance at the meeting.
