## **Report of the Head of Legal Services**

1. **LICENSING (2003) ACT**  
**TRANSITIONAL PREMISES LICENCE APPLICATIONS –**  
**KITTY O’SHEAS, PONTARDAWE**

The Sub Committee was asked to consider the undermentioned licence applications for both conversion and variation of a Transitional Premises Licence for the above mentioned premises.

The applicant, Mr.P.Rees, together with his daughter, attended the meeting in support of the application.

(a) **Conversion Application**

The Sub Committee was informed that, as the premises had traded as a Public House for many years, the applicant would be entitled to a premises licence for the sale of alcohol, with the previous permitted hours becoming conditions of the new Licence.
