1. **LICENSING (2003) ACT – TRANSITIONAL PREMISES LICENCE APPLICATIONS – COLLIERS ARMS, 154 SWANSEA ROAD, TREBANOS, PONTARDAWE**

The Sub Committee was asked to consider the licence applications for both conversion and variation of a Transitional Premises Licence for the above mentioned premises.

The applicant, Mr.R.Cobb, of Punch Taverns Plc attended the meeting in support of the application.

(a) **Conversion Application**

The Sub Committee was informed that as the premises currently traded as a public house and there were no representations from the Police, the applicant would be entitled to a premises licence for the

sale of alcohol with the previous permitted hours becoming conditions of the new licence.
