1. <u>APPLICATION FOR A PREMISES LICENCE – TAIBACH R.F.C.,</u> 23 COMMERCIAL ROAD, TAIBACH, PORT TALBOT

The Sub Committee was asked to consider an application for a Premises Licence for Taibach R.F.C., 23 Commercial Road, Taibach, Port Talbot.
