#### 1.2 Background Information

(provided by the applicant)

Taibach RFC is a club that was established in 1884. It owns its own premises and is a central part of the community of Taibach. It operates a bar, lounge and first floor function room known as the Talbot Suite. It has an enclosed outside area for smoking. Alcohol sales on and off the premises are made. Live music, recorded music, performances of dance take place. Activities like music/dance are provided. There are facilities for making music/dance. Stage shows are provided, films are shown, conference facilities are available, celebratory functions like wedding receptions, engagements, wakes take place, food is provided. Darts and pool are played, rugby teams represent the club.

#### 1.3 **Promotion of Licensing Objectives**

The following information has been provided by the applicant: -

## <u>General – all four licensing objectives</u>

The club is based within the community of Taibach and is successful. It wants to open the premises to non members in the community. This will sustain its appeal and financial viability. It will offer facilities to members and non members. It will operate in a responsible manner as it always has.

#### The Prevention of Crime and Disorder

Security staff and attendants will be employed as and when necessary. The Police will be alerted in case of any problems. Troublemakers will be banned. I.D will be required if necessary.

#### Public Safety

Regular fire and electrical tests undertaken. Environmental Health standards employed. Requirements of the Fire Officer are met.

#### The Prevention of Public Nuisance

No re-admittance to the club premises will take place after 11pm to allow an orderly dispersal until closing time. Windows and doors will be secured to prevent light and noise pollution. No smoking at the front or loitering outside or in the front will be allowed.

#### The Protection of Children from Harm

ID will be required if necessary. Children under the age of 12 will have to be accompanied by an appropriate responsible adult. No admission to plays or films other than in accordance with the licensing policy.

#### 1.5 Policy Considerations

## **Licensing Policy**

- 6.2 The Council acknowledges that licensed premises, especially those offering late night/early morning entertainment, alcohol and refreshment for large numbers of people, can be a significant source of crime and disorder problems. The Council expects the licensing trade to fully co-operate and play its part in minimising crime and disorder.
- 6.5 Applicants will be required to consider measures to prevent crime and disorder. The following are examples of control measures that may need to

be addressed in the operating schedule, having regard to their particular type of premises and/or activities: -

- (a) Effective and responsible management of premises
- (b) Training and supervision of staff
- (c) The internal layout and the location of various pieces of equipment within premises, including the position of cash registers, gaming machines etc.
- (d) The provision location and suitability of any CCTV and the need for Police and local authority to have right of access to tapes.
- (e) The use of plastic or toughened drinking vessels.
- (f) The adequacy of staffing levels to maintain a safe environment.
- (g) Management policy and action in relation to people who become intoxicated or disorderly.
- (h) Participation in Pub watch or other similar schemes.
- (i) The controls in place to prevent the use or supply of illegal drugs, including entry policies and search procedures.
- (j) The policy/procedure in respect of age verification and preventing sales of alcohol to under age people.
- (k) Adoption of best practice guidance (e.g. safer clubbing, Security by design etc)
- (l) The likelihood of disorder, if a licence is granted.
- 8.1 Licensed premises, especially those operating late at night and in the early hours of the morning can cause a range of nuisances impacting on people living, working or sleeping in the vicinity of the premises. The Council wishes to maintain and protect the amenity of residents and businesses from potential consequence of the operation of licensed premises. However it also recognises
- 8.2 The Council will expect operating schedules to demonstrate that suitable and sufficient measures have been identified, and will be implemented and maintained to prevent public nuisance. The extent and nature of these measures will be determined by the style and characteristics of the premises and events

## Secretary of State's Guidance

2.6 Conditions are best targeted on deterrence and preventing crime and disorder. For example, where there is good reason to suppose that disorder may take place, the presence of closed-circuit television cameras both inside and immediately outside the premises can actively deter disorder, nuisance

and anti-social behaviour and crime generally. Some licensees may wish to have cameras on their premises for the protection of their own staff and for the prevention of crime directed against the business itself or its customers. But any condition may require a broader approach, and it may be necessary to ensure that the precise location of cameras is set out on plans to ensure that certain areas are properly covered and there is no subsequent dispute over the terms of the condition.

- 2.7 Similarly, the provision of requirements for door supervision may be necessary to ensure that people who are drunk or drug dealers or carrying firearms do not enter the premises, reducing the potential for crime and disorder, and that the police are kept informed.
- 2.33 Public nuisance is given a statutory meaning in many pieces of legislation. It is however not narrowly defined in the 2003 Act and retains its broad common law meaning. It is important to remember that the prevention of public nuisance could therefore include low-level nuisance perhaps affecting a few people living locally as well as major disturbance affecting the whole community. It may also include in appropriate circumstances the reduction of the living and working amenity and environment of interested parties (as defined in the 2003 Act) in the vicinity of licensed premises.

## 1.6 Officer Report

This premises currently hold a club premises certificate authorising the supply of alcohol to members and regulated entertainment. The current operating hours of the premises are shown below: -

#### Conditions attached to the current club certificate

- Beer Garden to close at 22.00
- Premises to close 30 minutes after end of licensable activities
- Premises will open for an additional hour on the Sunday before a Bank Holiday Monday.
- 12 special event days per calendar year, 10 days notice to Police who will have absolute veto.
- Door and windows will be closed whenever regulated entertainment is provided.
- A documented procedure must be in place to verify the age of person who appear to be under eighteen years of age to prevent them gaining access to the premises and / or purchasing alcohol.

The means of verification should be restricted to:-

- 1. Accredited Proof of Age Scheme's e.g Portman, Validate
- 2. Photocard driving licence or passport.

Negotiations between the Police and the applicant have resulted in their representation being withdrawn. A copy of the agreement is shown at appendix 3.

The applicant has also agreed with the Environmental Health Officer that the following condition be included on any licence issued "Entertainment noise shall be inaudible inside any noise sensitive property" Consequently the representation from the Environmental Health Officer has been withdrawn.

The representations that remain are those that have been made by the five interested parties i.e. local residents.

#### 2.0 Small Society Lottery Registrations

#### **Purpose of Report**

To consider the cancellation of small society lottery registrations where the relevant organisation has failed to pay the annual fee.

#### **Background**

Lotteries are defined as games of chance where no element of skill is involved. Thus raffles, prize draws and sweep stakes etc. are all deemed to be lotteries. A registration is required where the public are invited to participate.

Society lotteries are lotteries promoted for the benefit of a non-commercial society. A society is non-commercial if it is established and conducted:

- for charitable purposes;
- for the purpose of enabling participation in, or of supporting, sport, athletics or a cultural activity, or
- for any other non-commercial purpose other than that of private gain. Examples of these are football clubs, rugby clubs and parent teachers association.

In September 2007 registrations held with the authority under the Lotteries and Amusements Act 1976 were transferred into registrations under the Gambling Act 2005. The Gambling Act 2005 dictates that the promoting society must, throughout the period during which the lottery is promoted, be registered with the local authority in which their principal office is based.

Registrations run for an unlimited period, unless the registration is cancelled. The current fee for registration is £40 and the society is required to pay an annual fee of £20.

If a registered society fails to pay the annual fee the authority may cancel the society's registration. A letter informing the society that the annual fee is due is sent at least one month before the due date. A further letter informing the society that payment has not been received is sent once the fee becomes overdue.

A list of the societies that have failed to pay their annual fee and the date on which this fee was due is shown at appendix 4.

## **Recommendation**

That members cancel the Small Society Registrations relating to the listed organisations with immediate effect.

- In paragraph M on page 12, there is no indication as to the extent of alcohol consumption, whether on or off the
  premises, or both.
- In the same paragraph, reference is made to seasonal variations and non-standard timings, but it not specified what these are.
- In paragraph O on page 13, non standard timings refer to Major Sporting Events. The extent and frequency of this request needs to be specified.
- 4. In paragraph P, section d on page 14 "No re-admittance after 11pm" should include admittance also.
- 5. In paragraph P, section e on page 14, children under 16 years must be accompanied by an adult.

Dear Sirs,

I would like to object to the proposed license extension of Taibach Rugby Club.

I currently live in the property next door to the Rugby Club in Taibach and have been made aware that an application for an extension of licence has been made on behalf of the Rugby Club extending the current licensing hours from 11pm Sunday to Thursday and midnight Friday and Saturday, to 2am, 7 days per week.

At present, the weekend licensing hours can impose on my quality of life, due to the midnight finish of the Rugby club and the customers leaving, taxis arriving, for at least an hour after that time.

I have suffered damage to my car and property, and have had windows in my property smashed and my front door suffered such damage that it had to be replaced. The police have attended the Rugby Club on several occasions.

The noise from the Rugby Club is sometimes intolerable as it is audible even when windows and doors are shut. Occasional youth parties at the Rugby club tend to escalate the problems outside at night further.

I fully accept that I live next to a licensed premises. However, with the proposed extension of 2 hours per night, the noise and potential damage to myself and other residents of this area who are probably unaware of the proposed extension of licensing hours, (as the extension of hours is not shown on the circulated application), will be unacceptable, and extend the current general disruption of the weekend, to 7 days a week.

#### RE: Proposal for an extension to the Licence at the Taibach Rugby Club

To whom it concerns,

I am writing regarding the proposal of the extension of licence to the Taibach Rugby Club. Firstly, I think it is **disgraceful** that you have considered this proposal as rules regarding their current licence are not being executed. As I am aware, current regulations state that all window and doors are to be shut by 10pm, as the club is located in a residential area. However, this does not happen as doors are still open until midnight, and music **blasts** not only from the jukebox but also from the featured DJ allocated in parties.

Secondly, extending the late licence will increase the number of underage juveniles drinking **alcohol** and taking **drugs** in the neighbouring Ffrwdywllt St lane. Not only is this disruptive to the residents, but when using this lane for access to the rear of the property, parking cars in garages etc, you have to tolerate the **stench of urine** and dodge the large amounts of glass bottles which are strewn all over the floor. This potentially resulting in the damage of vehicles for both residents and businesses.

Moreover, with the build up of youths who get out of control, residents in addition; have to put up with **vehicles getting damaged**. Several **wing mirrors** have been hit and cars have been **scratched**. Out of control youths result in the **police** being called to try and control the overpowering, disrespectful, immature idiots.

In addition, on big event days such as International Tests and local derbies, not only is it the youths residents have to put up with, there are adults who also do not show residents value with the use of foul language which can be heard from both the rear and front of the premises which does not set an example to visitors to the area or other members of the public using other amenities in the area.

Furthermore, being a residential area, and the club being located in-between two schools, an extension of the licence will upset the parents of young children in the community by **noise levels being exceeded** when people are evacuating the premises not giving consideration to the neighbouring residents.

I hope you will give this proposal deep thought, as an extension to the licence is an **appalling** idea not supported by the residents in Taibach.
