2. <u>APPLICATION FOR A VARIATION OF PREMISES LICENCE – KATZ, QUEEN STREET BACK ROAD, NEATH</u>

The Sub Committee was asked to consider the application for the variation of a premises licence for the above mentioned premises. The applicant, Mr K.Singh, together with the Designated Premises Supervisor, L.W.Absalom, attended the meeting in support of the application.

The circulated report contained details of the responses from the responsible Authorities. An amendment Report was also tabled at the meeting which indicated that the representations from the responsible Authorities would be withdrawn if the conditions required were met by the Applicants. The first representation from the Environmental Health Section required that any entertainment noise be inaudible at any residential property. The second representation contained a number of conditions from the Police Authority.

The applicant agreed to meet the conditions. However it was necessary for the Fire Authority to provide permitted numbers, and these were not available at present. A further condition required a barrier to the erected outside the entrance/exit. This barrier would be situated on the highway. As the Highway Authority had not been contacted regarding consent, the hearing was adjourned.

RESOLVED: That consideration of the matter be deferred until

further information could be obtained regarding

the above mentioned conditions.

3. <u>APPLICATION FOR A CLUB PREMISES CERTIFICATE – PORT TALBOT BOWLING CLUB, YNYS STREET, PORT TALBOT</u>

The Sub Committee was asked to consider an application for a Club Premises Certificate. Mr Perring attended the meeting in support of the application. There were no representations from the Police or Fire Authorities or from the Environmental Health Section. However, two of the residents who had made written representations were present at the meeting.

In accordance with the prescribed procedure the Sub Committee heard representations from the applicant and the two residents in attendance and also questioned all the parties present. The circulated report contained details of the information provided by the applicant relating to the promotion of the four licensing objectives.

The Sub Committee adjourned following receipt of all representations prior to the final decision.
