No information provided.

1.5. Promotion of Licensing Objectives

The following information has been provided by the applicant:

General - All Four Licensing Objectives:

The premises has a well documented Management and Staff Training Policy.

All staff are fully conversant with the Premises Operating Policies, compliance of which is a condition of employment.

The Prevention of Crime & Disorder:

The premises has CCTV coverage consisting of 4 cameras, with a 30 day retention of images by way of Video Tape.

The premises has a comprehensive drugs policy, which includes staff training on the identification of common controlled drugs, symptoms of drug use and indications of drug misuse and residue. As part of the policy, staff are instructed to carry out regular checks of all public areas including toilets (and external drinking areas).

Any door supervisors employed at the premises, must be registered by the Security Industry Authority.

The premises fully complies with the Government's Safer Clubbing policy in relation to maintaining a safe temperature, the provision of free drinking water, regular breaks during periods of fast music and the welfare of its staff and customers.

The premises has a transport policy and a local Taxi Company is recommended for use by customers.

The premises operates a random search policy, whereby customers are routinely searched for illegal substances, alcohol and weapons.

The premises has clearly defined Conditions of Entry, which are pointed out to all customers on entry. These conditions cover searching of customers, both on entry and as to remain on the premises, disorderly conduct and drunkenness.

The premises has a glassware policy and plastic containers are supplied for use outside the premises.

The consumption of alcohol in open containers purchased inside the premises is only permitted in designated areas within the perimeter of the property. No open containers are supplied for on-street drinking. The premises has a comprehensive proof of age policy and notices are displayed in prominent areas informing customers that they may be required to produce relevant proof of age documents.

The premises are part of the Neath Pub and Club Watch scheme and all staff are aware of the requirement to telephone neighbouring licensed premises to alert them to any persons ejected or likely to cause problems to other licensed premises.

The premises has a 45 minute period at the end of sales of alcohol, to allow customers to disperse in an orderly and leisured manner. This extended period ensures that customers leave in small groups at a time most suited to themselves rather than waiting for others thus all leaving together.

Public Safety:

The premises fully comply with the requirements of the Fire Service having regard to alarms, firefighting equipment, fire escape routes and staff training.

The premises has a Fire Safety Policy.

The premises has a Disability Policy, which includes staff training on the provision of facilities for disabled persons and also the safe evacuation of such persons in the event of an emergency.

There is a regular supply of fresh water available for the customers use.

Numbers at the premises are strictly controlled in accordance with the capacity of the premises.

The music policy at the premises ensures that there are regular breaks in periods of fast music in order to allow dancers to cool down.

The Prevention of Public Nuisance:

The premises are aware of its responsibilities to its neighbours, local residents and the wider community.

All staff have received training in relation to noise and the importance of "good neighbourliness".

Notices have been placed at all exterior doors reminding exiting customers of their responsibilities.

The Protection of Children from Harm:

Access for children to the premises is as follows:

Unlimited to 2100 hrs daily.

The premises has a comprehensive age policy and all staff have received training with regard to acceptable proof of age documentation.

All staff have been trained in relation to offences which may be committed under the Licensing Act 2003, in particular those relating to the sale and consumption of alcohol by persons under the age of 18 years.

- 8.5. In premises where regulated entertainment is provided, the licensing authority will require a documented noise assessment for the premises, which must indicate whether there is likely to be any nuisance or disturbance to the local community, and if so, what measures are to be implemented to prevent this.
- 8.6. The licensing authority may at its discretion waive the requirement for a noise assessment where it can be demonstrated that the nature, type or location of the premises is such that the likelihood of nuisance arising is negligible.

- 7.41 Conditions relating to noise nuisance will normally concern steps necessary to control the levels of noise emanating from premises, from simple mechanisms like ensuring that doors and windows are kept closed after a particular time in the evening to more sophisticated mechanisms like sound level inhibitors on amplification equipment or sound proofing. Any conditions necessary to promote the prevention of public nuisance should be tailored to the style and characteristics of premises and the type of activities expected to take place there.
- 7.42 As with all conditions, it will be clear that conditions relating to noise nuisance may in certain circumstances not be necessary where the provisions of the Environmental Protection Act 1990 and of the Noise Act 1996 adequately protect those living in the vicinity of the premises in question. But as stated earlier in this Guidance, the approach of licensing authorities and responsible authorities should be one of prevention and when their powers are engaged, licensing authorities should be aware of the fact that other legislation may not adequately cover concerns raised in relevant representations and additional conditions may be necessary.
- 7.43 Where applications have given rise to representations, any necessary and appropriate conditions should normally focus on the most sensitive periods. For example, music noise from premises usually occurs from mid-evening until either late evening or early morning when residents in adjacent properties may be attempting to go to sleep or are sleeping. In certain circumstances, conditions relating to noise may also prove necessary to address any disturbance anticipated as customers enter and leave the premises and therefore, in the immediate vicinity of the premises.

1.8. Officer's Report

The police express concerns at the proposal to open for sporting events at the discretion of the licensee. Alternative arrangements are proposed which would be acceptable to the police.

The environmental health officer raises representations in respect of the risk of nuisance due to the extended hours sought and suggests that these are not approved and that the operation of the beer garden be restricted.

1.9. Recommendation

As part of the policy, staff are instructed to carry out regular checks of all public areas including toilets (and external drinking areas).

Any door supervisors employed at the premises, must be registered by the Security Industry Authority. The premises has a transport policy and a local Taxi Company is recommended for use by customers.

The premises has a glassware policy and plastic containers are supplied for use outside the premises.

The consumption of alcohol in open containers purchased inside the premises is only permitted in designated areas within the perimeter of the property. The premises has a comprehensive age policy and all staff have received training with regard to acceptable proof of age documentation.

An adult over the age of 21 must accompany all persons under the age of 18 years.

The proposed variation will promote the public safety objective in accordance with the Section 182 Guidance.

The premises will operate in accordance with all relevant legislation, which promotes the public safety objective including, but not limited to the Health & Safety At Work etc Act 1974 and associated regulations, the Food Safety Act 1990, the Fire Precautions (workplace) Regulations 1997 and the Disability Discrimination Act 1975.

A zero tolerance towards illegal drugs will operate at all times. Any drinks promotions will not adversely affect the promotion of responsible drinking.

The existing fire safety precautions will be retained and maintained. A CCTV system will operate during the hours when licensable activities are provided.

The Prevention of Public Nuisance:

The public nuisance objective has been considered in the light of the proposed variation.

The proposed variation will not alter the style and operation of the premises and will not have an adverse effect on the public nuisance objective.

The proposed variation will promote the public nuisance objective in accordance with the Section 182 Guidance.

A Public Bar with two bars, a Games Room and a Beer Garden. Holding a Justices Licence for the sale of alcohol for consumption on or off the premises.

6.5. Promotion of Licensing Objectives

The following information has been provided by the applicant:

General - all four licensing objectives:

The Prevention of Crime & Disorder:

Use of toughened glasses

Effective and responsible management of the premises.

Training of staff in the respect of age verification.

The prevention of underage people purchasing alcohol for consumption on or off the premises.

Public safety:

Use of toughened glasses.

Suitable training and supervision of those employed to secure the safety of customers on the premises.

Proof of regular testing of appliances and systems pertinent to safety.

The Prevention of Public Nuisance:

Steps taken to control the emission of noise. Systems in place to deal with disorder. Measure to be taken to ensure windows and doors kept closed when amplified music is being played.

Prominent signs requesting patrons to consider local residents.

Arrangements with local taxi firms not to use horns when arriving or leaving with patrons.

The Protection of Children from Harm:

To require proof of age, cards or other I.D where alcohol is sold.

6.7. Policy Considerations

It is considered that the following policies are relevant to this application:

Statement of Licensing Policy

- 6.6 In addition to the requirements that the Council promote the licensing objectives, it also has a duty under Section 17 of the Crime and Disorder Act 1998 to do all it reasonably can to prevent crime and disorder in the County Borough. The council is required therefore to have particular regard to the likely impact of licensing on crime and disorder. The nature or type of premises, its location, the hours of operation, its impact on the area, the operation and management of premises are all significant factors, which can impact on crime and disorder. All applications for licences or certificates including renewals and variations will be expected to have addressed these matters within the operating schedule.
- 6.9 The Council considers that certain types of premises are likely to require additional measures or conditions due to the nature, type and mode of operation. These would include premises, which sell alcohol and cater mainly for the 16-25 age group and provide regulated entertainment, or premises which provide events or entertainment mainly for children.

In order to ensure the safety of patrons and other persons in the vicinity of the premises, the council suggests that operating schedules give consideration to the following measures and may require any or all of these measures to be implemented in the interests of minimising crime and disorder.

(i) Door Supervisors

The need for door supervisors is normally a matter, which is considered and determined by the applicant within the operating schedule. However, where an applicant has made no provision for providing door supervisors, but it is considered that they are essential to meet the crime and disorder or public safety objective the council may specify that the premises must provide registered door supervisors. The council may also require a duty log / register of door supervisors be kept for the premises. Where door supervisors are provided they must be licensed by the Security Industry Authority. Generally one door supervisor per 100 persons would be required to be present on the premises. However, additional supervisors may be necessary in certain situation, e.g. where there is a significant number of very young persons, or where there is a potential for boisterous or excitable behaviour, e.g. stag nights; football matches; celebrity visits. Applicants are advised to give consideration to these matters within the operating schedule as well as the days and hours of operation of the door supervisors.

7.0 Public Safety

- 7.5 Certain types of premises, due to the nature of activities being provided, may give rise to a significant risk if occupancy numbers are not set. The council following representations will consider setting occupancy limits particularly in respect of the following types of premises:
 - (i) night clubs/public houses providing regulated entertainment (ii) theatres
 - (iii) cinemas
 - (iv) any other premises where the authority is satisfied that the nature and operation of the premises is such that it requires regulation of numbers at the premises.
- 7.6 The council following representations may also impose occupancy limits when it considers it appropriate for other reasons, e.g. to

minimise crime and disorder.

8.0 Prevention of Public Nuisance

- 8.3. The Council may require applicants for premises licences to provide documented noise assessments with a view to minimising noise nuisance.
- 8.4. Noise from amplified music is a common source of disturbance. In order to minimise the impact in the vicinity, the licensing authority may require a range of measures to be taken. These may include the installation of soundproofing, air conditioning, acoustic and sound limitation devices.
- 8.5. In premises where regulated entertainment is provided, the licensing authority will require a documented noise assessment for the premises, which must indicate whether there is likely to be any nuisance or disturbance to the local community, and if so, what measures are to be implemented to prevent this.
- 8.6. The licensing authority may at its discretion waive the requirement for a noise assessment where it can be demonstrated that the nature, type or location of the premises is such that the likelihood of nuisance arising is negligible.

Secretary of State's Guidance

Public Safety

7.34 Where applications have given rise to representations, any necessary and appropriate conditions should normally focus on the most sensitive periods. For example, music noise from premises usually occurs from mid-evening until either late evening or early morning when residents in adjacent properties may be attempting to go to sleep or are sleeping. In certain circumstances, conditions relating to noise may also prove necessary to address any disturbance anticipated as customers enter and leave the premises and therefore, in the immediate vicinity of the premises.

Prevention of Public Nuisance

7.41 Conditions relating to noise nuisance will normally concern steps necessary to control the levels of noise emanating from premises, from simple mechanisms like ensuring that doors and windows are kept closed after a particular time in the evening to more sophisticated mechanisms like sound level inhibitors on

amplification equipment or sound proofing. Any conditions necessary to promote the prevention of public nuisance should be tailored to the style and characteristics of premises and the type of activities expected to take place there.

- 7.42 As with all conditions, it will be clear that conditions relating to noise nuisance may in certain circumstances not be necessary where the provisions of the Environmental Protection Act 1990 and of the Noise Act 1996 adequately protect those living in the vicinity of the premises in question. But as stated earlier in this Guidance, the approach of licensing authorities and responsible authorities should be one of prevention and when their powers are engaged, licensing authorities should be aware of the fact that other legislation may not adequately cover concerns raised in relevant representations and additional conditions may be necessary.
- 7.43 Where applications have given rise to representations, any necessary and appropriate conditions should normally focus on the most sensitive periods. For example, music noise from premises usually occurs from mid-evening until either late evening or early morning when residents in adjacent properties may be attempting to go to sleep or are sleeping. In certain circumstances, conditions relating to noise may also prove necessary to address any disturbance anticipated as customers enter and leave the premises and therefore, in the immediate vicinity of the premises.

6.8. Officer's Report

The representations of the Police refer to issues of crime and disorder, public safety and prevention of public nuisance.

Recommendations are made to deal with some of these matters.

The Environmental Health Officer makes representations in respect of prevention of public nuisance, and proposed measures to alleviate any problems.

Due consideration should be given to these representations as well as the applicants representations.

6.9. Recommendation

That members determine the application after taking into account the representations received.
