COUNCIL TAX - RECOVERY OF COSTS

Purpose of Report

1. To determine the level of costs to be recovered from council taxpayers in respect of the issue of summonses and the granting by the Magistrates of liability orders.

Background

- 2. The legislation governing the administration of council tax provides that reasonable costs may be recovered:
 - on the issue of a summons
 - on the granting by the Magistrates of a liability order.
- 3. Current costs are recovered as follows:

on the issue of a summons
on the granting of a liability order
£35.00
£20.00

- 4. The levels were determined following a survey of Welsh authorities which indicated that there was a wide variation in the level of costs recovered from £28.00 to £93.00, with our neighbouring authorities, Swansea and Bridgend, charging £60.00 and £93.00 respectively in 2007/08.
- 5. It is normal policy to review the level of costs charged on an annual basis, and to increase those costs at least broadly in line with inflation. It is recommended, therefore, that the following level of costs be charged for 2009/10:

on the issue of a summons
on the granting of a liability order
£21.00

- 6. This represents an overall increase of 3.6% and will generate additional income of around £3,000 compared to the 2008/09 budget.
- 7. By way of comparison, the Retail Prices Index increased from November 2007 to November 2008 as follows:
 - all items (excluding mortgage interest) = 3.9%
 - all items (including mortgage interest) = 3.0%

Recommendation

8. It is recommended, therefore, that the costs be increased with effect from 1st April 2009 to the following:

• on the issue of a summons - £36.00

• on the granting of a liability order - £21.00

£57.00

- 2. The legislation governing the administration of business rates provides that reasonable costs may be recovered:
 - on the issue of a summons
 - on the granting by the Magistrates of a liability order.
- 3. Current costs are recovered as follows:

on the issue of a summons
on the granting of a liability order
£36.00
£29.00

- 4. The levels were determined following a survey of Welsh authorities which indicated that there was a wide variation in the level of costs recovered from £28.00 to £93.00, with our neighbouring authorities, Swansea and Bridgend, charging £60.00 and £93.00 respectively in 2007/08.
- 5. It is normal policy to review the level of costs charged on an annual basis, and to increase those costs at least broadly in line with inflation. It is recommended, therefore that the following level of costs be charged for 2009/10:

on the issue of a summons
on the granting of a liability order
£37.00
£30.00

6. This represents an overall increase of 3.1% and will generate additional income of around £2,500 compared to the 2008/09 budget.

7. It is recommended, therefore, that the costs be increased with effect from 1st April 2009 to the following:

on the issue of a summons
on the granting of a liability order
£37.00
£30.00

£67.00
