1 COMMUNITY SAFETY PROJECTS FUND: APPLICATIONS FOR DECISION

Purpose of the Report:

To decide upon applications received for grant funding from Community and Voluntary Organisations and from the Safer Neath Port Talbot Partnership.

Background:

Introduction

Since 2000/2001 the Council has provided financial assistance to community-based and voluntary organisations to fund projects and schemes, which are designed to contribute towards the objectives of the Community Safety Strategy. The Safer Neath Port Talbot Partnership also develops projects for the same purpose. The combined budget for these purposes for 2011/12 is £12,000.

The Process

Grant application forms are available from the Council's Community Safety Team which offers advice and guidance to applicants on the eligibility criteria and completion of the application form. Applications are assessed against the eligibility criteria prior to the application being reported to the Cabinet Board for determination. Safer Neath Port Talbot Partnership submissions are agreed between the relevant partners prior to be presented for decision. Appendix 1 shows applications approved to date.

Community-based Projects

Organisation Project Grant
1. Friends of Sandfields Motiv8 £500

Motiv8 is a learning and activity project which aims to address social issues that lead to offending. The project will run in the Easter holidays when the youth club provision is closed delivering workshops with partners looking at the consequences and repercussions of crime and anti-social behaviour. The project is accredited and 20+ young people have signed up to take part. The funding will pay for the accreditation tutor cost and training materials.

Organisation Project Grant 2. Faith Youth Group Alpha - Omega £500

The Project is aimed at getting more young people of 11 - 16 off the streets in the area of Glynneath and into social activities. The project will be located in Bethania Community Centre and will meet one day a week initially, with further activities and events planned throughout the year. The group have asked for initial running cost i.e. hall hire and materials but through setting up a tuck shop are hoping to make the youth project sustainable.

SA12	Cycle Safety	£900

The SA12 youth club is open to young people 11 - 25 years in the Aberavon area. Many of the young people cycle to the club and there is no provision for bikes to be stored in the building. The project aims to install a cycle rack which can also be used by other community groups to reduce the amount of cycle theft in the area. Road Safety will provide training on safe cycling. More young people will be encouraged to use their cycles promoting physical fitness as well.

Safer NPT Partnership	Stop Repeat Scheme	£2,070

The aim of the Stop Repeat Victim Scheme is to prevent victims of crime, in particular Domestic Abuse, from becoming repeat victims. Working in partnership with Mid & West Wales Fire Service, fire bags are fitted to the letter boxes of very high risk victims who have been threatened with arson. There have been a number of instances in NPT where perpetrators of Domestic Abuse threaten and even carry out acts of arson by putting inflammable articles through the letter box in an attempt to start a fire. The fire bags prevent this happening by extinguishing the fire. If the partnership is able to provide the fire bags the Fire Service will fit them and give appropriate advice to potential victims. The Fire Service has also negotiated a 25% discount for the purchase of the fire bags.

Recommendation:

It is recommended that the applications be approved.

Reasons for Proposed Decision:

The applications recommended for approval meet the eligibility criteria and the projects will contribute to the objectives of the Community Safety Strategy.

2 OFFICER URGENCY ACTION – REVIEW OF FEES PAID AT LOCAL ELECTIONS

Purpose of Report

This report sets out information relating to an Urgency Action approved by the Head of Corporate Strategy in conjunction with the relevant Cabinet Members.

Background

The current structure and scale of fees paid at local elections are based on those previously set by the former Neath, Lliw Valley and Port Talbot authorities. This Council adopted those scale of fees in 1996. The fees were last reviewed prior to the Local Government Elections in 2008, and now need to be revisited once again to ensure they continue to reflect the fees paid at national elections.

The most recent national election were the National Assembly for Wales elections held on 5 May 2011 combined with a referendum on the UK Parliamentary voting system. It is proposed that the fees paid for these elections are used as a benchmark for certain local election fees, excluding any referendum costs.

To ensure an accurate fees and charges scale structure is in place prior to the commencement of the election timetable and the appointment of appropriate staff for the forthcoming Local Government due to take place on 3 May 2012, two small revisions are required to the original report previously submitted to the Cabinet Board.

Certain staff fees were omitted from the original report and an amendment is required to the mileage rate claimed by Polling Station Inspectors as the previous mileage rate would be inadequate to compensate staff for the distances covered on polling day in conducting their duties. Both items are highlighted in the amended fee structure shown below.
