REVIEW OF FEES FOR THE REGISTRATION SERVICE

Purpose of Report

To set fees for the financial year 2010/2011 and 2011/2012.

Background

A schedule of the current fees for 2009/10 and proposed charges for 2010/11 and 2011/2012 is shown at the end of this report. A civil marriage or civil partnership ceremony can take place in any Register Office in England or Wales for a set fee plus the cost of the marriage certificate (£3.50). Alternatively the ceremony can take place at a venue that has been approved to hold a civil marriage or civil partnership such as a prestigious building or hotel etc. The cost for attendance by the Superintendent Registrar and Registrar is set by the Authority, and it is proposed that there is a modest increase for next year. A further fee is then charged to the couple by the owners of the building for the use of the premises.

We are also keen to offer additional services to residents of Neath Port Talbot with Renewal of Vows ceremonies and secular Baby Naming Ceremonies both in the Ceremony Room at London Road and at Approved Premises.
