2. MINUTES OF THE MEETING HELD ON THE 30TH NOVEMBER 2012

3. MEMBERS SEMINAR – 14TH NOVEMBER 2012

With regards to the recent landslide in Ystalyfera, officers highlighted how important it is for Elected Members to attend the resilience seminars which are arranged from time to time, as an incident can happen in any ward, at any time.

4. WALES AUDIT OFFICE REPORT (WAO) – CIVIL EMERGENCIES IN WALES

Members were briefed on the WAO report entitled "Civil Emergencies in Wales", published on 6th December 2012, as contained in Appendix 1 of the circulated report.

It was noted that the WAO report had taken two years to produce and some of the data was, therefore, out of date, However, there were several references in the report to good practice at Neath Port Talbot and Swansea. In particular, the existence and work of the Neath Port Talbot / Swansea Joint Resilience Committee had been highlighted.

The Chair complimented both Authorities for the work undertaken and the recognition shown by the Welsh Audit Office contained in the circulated report.

A report will be brought back to a future meeting of this Committee to update Members on the outcomes of the WAO report.

RECOMMENDED: that the report be noted.

5. SOUTH WALES LOCAL AUTHORITY RESILIENCE TEAM

The Committee were updated on the work undertaken by the South Wales Local Authority Team during 2012/13, ie the resilience staff employed by each of the local authorities which comprise the South Wales Police / South Wales Local Resilience Forum area.

The South Wales Local Authority Resilience Team would in future be operating under one brand, which would be rolled out during 2013/14. The team were currently meeting monthly to prepare a unified multi-agency resilience work programme for all seven local Authorities.

The Chairman stated that it was collaboration at its best where Local Authorities were working together on a large scale and should be publicised.

RECOMMENDED: that the report be noted.

6. SEVESO III DIRECTIVE BRIEFING PAPER

The Committee were given a brief overview of the Seveso III EU Directive that would come into force in June 2015, as detailed in the circulated report. The Seveso III Directives had been developed and adopted due to major chemical accidents. The Seveso accident in 1976 prompted the adoption of EU legislation aimed at the prevention and control of such accidents.

The Seveso directives now apply to around 10,000 industrial establishments where dangerous substances are used or stored. This could mean the number of COMAH sites increasing across Neath Port Talbot and Swansea, which would have an impact on the amount of work carried out by the JRU to fulfil its duties under the COMAH regulations. A further report would be submitted to this Committee in due course so that Members can be updated about further potential implications.

RECOMMENDED: that the report be noted.
