Report of the Head of Legal Services

1. <u>LICENSING ACT 2003 (HEARINGS) REGULATION 2005 –</u> <u>APPLICATION FOR A REVIEW OF A PREMISES LICENCE –</u> <u>JIMMYS BAR, 33 STATION ROAD, PORT TALBOT</u>

The Sub Committee was asked to consider an Application for the review of an existing Premises Licence for the above mentioned premises. The circulated report contained details of the Application made under the Licensing Act 2003.

The Licence Holder at Jimmy's Bar attended the meeting, along with her solicitor.

The Licensing Manager gave Members an overview of the circulated report and outlined the grounds for Review which had been submitted by the Police, with a representation that had also been made by the Licensing Section.

P.C.Williams outlined the reasons for the South Wales Police requesting a review of the premises license.

The Licensing Manager informed the Sub Committee of the 5 options that were available to them:-

- (a) To modify the conditions of the Licence;
- (b) To exclude a licensable activity from the scope of the Licence;
- (c) To remove the Designated Premises Supervisor;
- (d) To suspend the Licence for a period not exceeding three months;
- (e) To revoke the Licence.

The Sub Committee then adjourned in order to reach its decision.

RESOLVED: that the Premises Licence be suspended for a period of

three months and conditions numbered from 2 to 7, as proposed by the police and as detailed in the circulated

report, be approved.

2. <u>LICENSING ACT 2003 – APPLICATION FOR A PREMISES</u> <u>LICENCE – THE NEW EXETER, 52/54 BRITON FERRY ROAD,</u> NEATH

The Sub Committee was asked to consider an Application for a Premises Licence for the above mentioned premises. The circulated report contained details of the Application made under the Licensing Act 2003.

The Licensing Officer gave an overview of the circulated report and advised that the applicant had agreed to attach the conditions that were requested within the representation from the South Wales Police, which were outlined at Appendix 2 to the circulated report.
