CONVERSION AND PART DEMOLITION OF CLUB (USE CLASS D2) TO 12 NO.1 BEDROOM FLATS AND EXTERNAL
ALTERATIONS COMPRISING OF INSERTION AND
ALTERATION OF FENESTRATION AND PROVISION OF
ASSOCIATED CAR PARKING AT 72 -74 WINDSOR ROAD,
NEATH

(Councillor Mrs.S.M.Penry spoke on this item but withdrew from the room for the voting thereon).

The Sub Committee visited the above mentioned location. A copy of the original report was circulated for Members' consideration.

Following the site visit the Sub Committee discussed the application and took into account the Local Member's concerns in relation to parking issues.

The Planning Officer confirmed that following the site visit, the Officer's original recommendation of approval, subject to the conditions contained in the circulated report, remained unchanged, but subject to an additional condition, in response to the concerns raised by the Local Member.

#### **RECOMMENDED:**

that the above mentioned application be approved, subject to the conditions contained in the circulated report, and an additional condition set out below:-

(i) Prior to the commencement of work on site and notwithstanding the submitted plans, an alternative scheme for the provision of six off street parking spaces within the curtilage of the site shall be submitted to and agreed in writing by the Local Planning Authority. The proposed parking shall be provided in accordance with the agreed

scheme prior to the beneficial use of any of the proposed flats commencing, and shall be retained and maintained as such thereafter.

## Reason:

To ensure the provision of acceptable off street parking spaces in the interests of highway safety.
