Purpose of Report

Background

The ICCM operate a recycling of metals scheme, of which Margam Crematorium participates, where all residue metals are collected by a representative company of the ICCM and recycled. The surplus funds are then distributed to suitable local or national based death/bereavement related charities. For the last accounting period the scheme has produced a surplus of £350,000 and nominations for appropriate charities are being invited from all participating Crematoria.
