Matter for Decision

Wards Affected: Port Talbot & Margam

Proposed Traffic Orders: Port Talbot Transport Hub

Purpose of Report

1. To obtain Members' approval to advertise the Legal Orders for the implementation of Traffic Orders for the new road layout at the Port Talbot Transport Hub, as indicated in Appendix A.

Executive Summary

2. The report outlines the proposed Order and the reason why the Order is required.

Background

3. A new road layout is being implemented to accommodate the Port Talbot Transport Hub. A traffic scheme is necessary to prevent indiscriminate parking and prohibit entry to the new bus station for buses only.
