Purpose of Report

To seek member endorsement of an amendment to the previously agreed staffing arrangements in respect of meeting the new statutory duty of Sustainable Drainage Authorising Body

Executive Summary

2 This report seeks to correct a post grading error in the previous decision report.

Background

- 3.1 A joint report of the Head of Engineering and Head of Streetcare concerning resourcing arrangements to meet new statutory duties in respect of Sustainable Urban Drainage Systems was presented to committee on 25th June 2018. The 'SuDs' approval process, which comes fully into effect in January 2019 will run alongside the normal planning approval process.
- 3.2. There was an error in the report in that the proposed additional Drainage Engineer Post was stated as Grade 9 instead of Grade 10 as job evaluated, and the error was then carried through to the financial appraisal.

Financial Impact

- 4.1 The revision increases the total recurring cost of the previously agreed 3.5 additional posts in year 1 from £130,225 as given in the original financial appraisal to £135,607 (and the maximum cost at top of grade from £150,670 to £156,022).
- 4.2 As previously reported whilst these costs will be met in large part from existing budgets, the balance is expected to come from new fee income. It is reiterated however that it is not known at this stage whether all the costs associated with resourcing the new statutory duty will be met by the income from the fee charge, which has been set nationally, and furthermore the level of development going forward is somewhat unpredictable. It remains the case that the financial implications of meeting the new duty will therefore need to be review after a year or two of operation.
