**Renewal of Microsoft Software Enterprise Agreement** 

### **Purpose of report**

1. To seek approval to issue a direct award under the National Procurement Service Framework for Microsoft Software.

### **Background**

- 2. The Council requires a software license known as an Enterprise Agreement to use the various Microsoft Software Packages across the estate.
- 3. The Council's present use of Microsoft software is on the basis of a previous three year Enterprise Agreement contracted for in 2018. The agreement provided a product set consisting of the Windows Operating System and the Microsoft Office and Collaboration suite. The contract was issued on a subscription only basis and the right to use the software will lapse in June 2021. The current agreement is held with SoftCat PLC an IT Infrastructure and Service Provider who focus on the public sector

- 4. The Enterprise Agreement is provided under the Digital Transformation Agreement (DTA) which is negotiated by Crown Commercial Services (CCS) and provides preferential public sector discounts for the Microsoft Software.
- The new DTA was issued in May 2021 and the Council will need to complete the replacement contract prior to the end of the current agreement. Pricing has been adjusted in the new agreement with Microsoft significantly reducing the discount levels offered on all bar the premium product set.
- 6. The National Procurement Service Framework Agreement, NPS ICT-0094-19, provides a compliant Direct Award Call off Contract for the DTA agreement. The preferred supplier judged by the NPS as the most cost effective provider is SoftCat PLC.

### The Enterprise Agreement

- 7. The Enterprise Agreement is based on a subscription model whereby the software is leased. The Microsoft pricing model is geared towards making the Subscription model the most competitive and offers the highest degree of flexibility.
- 8. The subscriptions model provides the ability to increase, true up, or decrease, true down licenses during the lifetime of the agreement
- 9. Software provided under the agreement may be delivered on premise i.e. hosted on Council server infrastructure, via a cloud delivery, or a mix and match approach as service requirement demands.

- 10. The initial agreement covers the minimum purchase levels with the option to true up licenses as software is deployed. The costs of any additional licenses falls due on the next anniversary of the agreement.
- 11. Under the terms of the agreement any device licensed products may legitimately be used by partner agencies without incurring any additional cost.
- 12. Licenses may be migrated to a regional or all Wales agreement should one become available.
- 13. Products licensed under the agreement include:
  - Microsoft Windows Operating System
  - Microsoft Office
  - Microsoft Teams
  - Exchange
  - · Windows Server
  - · Sharepoint
  - · Yammer

## **Financial Impact**

14. The contract value will be set as part of the direct award process but will be in the region of £415,000 per annum. The current revenue budget is £350,000.

It is proposed to meet the first year deficit from the Digital Services Reserve and submit a Pressure for the financial year 2022/23

The actual three year sum will be based upon the usage requirements of the Council which will be subject to change through the three year lifespan of the licence agreement

21. It is recommended that Members approve the issue of a Direct Award for the renewal of the Microsoft Enterprise Agreement under the NPS Framework to SoftCat PLC.

22. To enable the Council to meet its license obligations and deliver the infrastructure to allow it to conduct its business

### Implementation of decision

23. The decision is an urgent one for immediate implementation, subject to the consent of the relevant Scrutiny Chair and is therefore not subject to the call-in procedure.
