3. Margam Crematorium were able to offer a respectful service to those suffering bereavement and to meet the needs of the public. At a time when services have been restricted to the number of invited guests of the family, webcasting of the service by Wesley Media has proved popular and invaluable. Services have been streamed across the world including Australia and New Zealand with many favourable comments being received. During the last financial year, over 300 services have been streamed. Members should note though that the Superintendent and officers will always work with families to accommodate their needs and in particular will undertake regular reviews of attendance numbers to ensure compliance with Welsh Government legislation and Statutory Guidance In addition, the Cremation Fee has remained unchanged since 1st April 2019 and was only nominally increased from the previous two years.
