PROPOSAL TO CREATE A TARGETED HARDSHIP RELIEF SCHEME

Background

The Cabinet has requested further advice as to how the remaining underspend for 2021/22 can be utilised to develop a range of measures to support those who are hardest hit by the cost of living crisis.

Proposal

Following publication of the latest revenue budget monitoring report which contains details of a further £2.3m underspend (after reserve transfers) the Cabinet has requested further advice in relation to how this underspend can be used to support those residents of the County Borough who are currently hardest hit by the cost of living crisis.

The proposal contained within this report is that £2m of this underspend be ring-fenced and transferred into a specific hardship relief reserve.

A hardship relief scheme will need to be developed to target those who are most in need and where we have opportunities to deliver those benefits over the next twelve months.

Once developed this scheme will be brought back to Cabinet for approval.

Integrated Impact Assessment

The development of a hardship relief scheme will assist the Council in meeting its obligations pursuant to the Equality Act 2010, the Welsh Language Standards (No.1) Regulations 2015, the Well-being of Future Generations (Wales) Act 2015 and the Environment (Wales) Act 2016. A detailed assessment will be undertaken as the hardship relief scheme is developed and when reported back to members.
