The Chair welcomed everyone to the meeting.

# 3. THE COST OF LIVING CRISIS - SUPPORT OFFERED BY SCHOOLS

Members were provided with information relating to the cost of living crisis and support offered by schools, as circulated within the agenda.

There were no questions raised. Members thanked officers for the information presented within the report detailed.

#### 4. PRE-DECISION SCRUTINY

### Admissions to Schools (Results of Consultation)

Members considered the report as detailed within the agenda circulated.

Members queried if officers had given any further consideration to the automation service for school admissions that has previously been discussed with school governors? Officers confirmed that they will look into it, but have not yet done so.

Following scrutiny, Members were supportive of the recommendation to be considered by Cabinet Board.

### **Quarter 3 Performance**

Members considered the information as presented within the report circulated with the agenda.

Members queried page 44, C P008, which relates to the 11 pupils studying Welsh. Members queried if enough was being done to ensure that the number of pupils studying Welsh continues to increase. Members were advised that this was part of the WESP strategy. For students to study in Welsh they need to have been doing this from an early age. This is an important aspect of the WESP strategy moving forward.

Members requested further information on the red indicator on page 48 relating to children looked after. Officers confirmed that one issue that is causing some problems is obtaining the required input from the health service.

Members raised queries with regards to communities for work on page 51 of the report. Members noted the lack of people engaging in the scheme. Officers confirmed that this item related to the over 25's and this is a more difficult category of age to reach, due to several factors, Officers confirmed that one of the targets that will be put in place will be to engage with businesses so that they advise what skills they're looking for. The scheme can then look at making sure that the people that are looking for a job have the right skills to match.

Members queried CP005 and 006 and sought an explanation for the drop in attendance. Officers confirm that attendance is one of the main priorities. COVID and subsequent recovery has had a massive impact on young people's mental health and well-being, and engagement with the school. This includes the family that sits behind the young children. Further, there is a huge dip in Friday attendance rates from the data that has been analysed.

Attendance is one of the targets within the Corporate Improvement Plan and the School Improvement Plan. Officers outlined the decline in attendance could also be attributed to the cost of living crisis. Officers have been working with Social Services to remove some of the identified impediments that are contributing to low attendance levels.

Officers outlined some steps that have been taken to address some issues raised and emphasised that there will be a concerted effort over the next 12-18 months to get attendance levels back to prepandemic levels.

Members queried if they could have information pertaining to attendance at each individual school as opposed to a blanket statement that covers all the borough. This can then be monitored moving forward.

Members were pleased to see the number of weddings exceed the projected KPI at the Orangery in Margam Park.

Following scrutiny, the report was noted.

### Free School Meals update

Officers outlined the report that was circulated with the agenda. Members congratulated officers for their hard work in rolling out the various age groups ahead of time. Members queried the capacity to continue to roll out the programme as outlined within the report. Officers advised that they understood that situation in each school and were confident that the programme can continue to be rolled out as planned. NPTCBC is one of three authorities in Wales who are currently at this stage in their programme rollout.

Members queried if the nutritional value of the meals was monitored. Officers confirmed that they have the certificate of compliance from Welsh Government that NPT covers and follows the Healthy Regulations 2013 for all the meals provided.

Members acknowledged that recruitment that had already taken place, but asked officers if there had been any issues with recruitment and could further extension of the programme be delayed by staffing requirements. Officers confirmed that there had been significant difficulty with recruitment however it had one that had been overcome to date. Officers confirmed that all staff were paid as appropriate for their job evaluated role.

Following scrutiny Member noted the report.

# Professional Learning

Members considered the report as circulated with the agenda. Members were pleased to see that the report noted the commitment of NPT to the development of teachers. Members noted the commitment to make NPT an attractive place to work and queried the support offered by the strategy in comparison to other authorities. Officers advised that they work closely with teachers to determine what support is required and how this can be offered.

Members also queried if there had been any change in the needs of teachers post COVID. Officers confirmed that it was not only post COVID but also the reform agenda in schools which is challenging teachers and where the greatest need for support is identified.

Members were asked to note that this is one aspect of professional learning. There is further learning in Early Years and Including

Service. The reform agenda covers many aspects and there is a huge amount of support in relation to this and ALN.

Officers confirmed that there are no obvious gaps in what is currently being provided to teaching staff and this has been confirmed by head teachers in their response to the recent question asked by Estyn.

Following scrutiny members noted the report.

Members asked that a regular update on attendance be provided to the committee.

#### 4. PRE-DECISION SCRUTINY

#### **Elective Home Education**

Members considered the report as circulated within the agenda pack. Members queried if the new guidance would place a statutory duty for all pupils to be registered within the education system. Officers were unable to confirm if this would be the case until the new guidance was published by Welsh Government.

Members expressed their concern in the significant rise in numbers that are being educated at home and the education that they are receiving. Members queried if there were sufficient staff to deal with the number of children being educated at home. Officers confirmed that there are currently two co-ordinators employed at present and this was sufficient.

Following scrutiny, Members noted the report for information.

#### **Equality and Safe Place to Learn**

The initiative for community focused schools has come directly from Welsh Government over the last 18 months. Officers outlined how Neath Port Talbot has utilised the funding from Welsh Government to focus on this area.

Members queried if there was any work that could be done with governing bodies to better understand community links and things that organisations within the community can offer. Officers advised that the new curriculum provides a lot of focus on engagement within the community. Further, a piece of work is being carried out on 'asset based community development.' This considers what is available within the communities and how to engage the schools within what is already available. It will look at the reciprocal arrangements between the schools and the community organisations.

Following scrutiny, the report was noted for information.

# **Period Dignity Report**

Members considered the report as circulated within the agenda pack.

It was confirmed that comprehensive schools are provided with funding to purchase items as required. Primary schools are emailed to ask if they would like products and if so, what products are required. Primary schools are also entitled to replacement uniform from the funding.

Following scrutiny, members noted the report for information.

### **NEET (Not in Education, Employment or Training) Update Report**

Members considered the report as circulated within the agenda. Members were provided with updated destination figures. 2.2% of young people transition from school into NEET. This is the second best year ever within Neath Port Talbot and relates to only 35 young people.

Members queried the figures presented on the graph, specifically relating to 2018. Officers advised that there were discrepancies in the All Wales reporting for that year, with one local authority not presenting their figures on time.

Members raised the concerns outlined in one of the case studies in relation to assistance dogs. Members queried if the authority would consider developing a model risk assessment to support this in the future. Officers advised they are mindful of the situation moving forward.

Following scrutiny the report was noted.

#### PUPIL ATTENDANCE UPDATE

# **Purpose of the Report**

1. To provide Members with information and data in relation to Pupil Attendance.

## **Background**

- 2. This report provides Members with key information relating to Pupil Attendance and current data taken as a snapshot at the time of the report, up to 30th April 2023.
- 3. In the current academic year to the end of April, the primary sector attendance rate was 89.76%. This has increased by 0.36% compared to the same period the previous year. The Secondary sector attendance during this period was 86.34%. This has increased by 0.85% compared to the same period the previous year. See appendices one.
- 4. 36 primary schools improved their attendance, when compared with the same period last academic year; where only 10 primary schools had improved their attendances, this is an improvement by 26 schools. Last academic year, 48 primary schools reported a decrease in their attendance; this has now decreased to 22.
- 5. 7 secondary schools improved their attendance, when compared to the same period last academic year: where only 2 schools improved, this is an improvement by 5 schools. Last academic year, 8 secondary

- schools reported a decrease in their attendance: this has now decreased to 3 schools.
- 6. Attendance at school is improving when compared to the same period last academic year. As a service, we have recently met, to look at strategies, using a creative thinking session to help support schools to improve pupil attendance further.
- 7. There has also been improvement when comparing the data relating to FSM and ALN.
- 8. In the current academic year to the end of April, the primary sector FSM attendance rate was 85.40%. This has increased by 0.13% compared to the same period the previous year. Non-FSM attendance at the same snapshot is 91.69%. This has increased by 0.44% when compared to the same period the previous year.
- 9. The Secondary sector FSM attendance during this period was 78.05%. This has increased by 0.08% compared to the same period the previous year. Non-FSM attendance is 89.32%, this has increased by 1.1% when compared to the same period the previous year.
- 10. In the current academic year to the end of April, the primary sector ALN attendance rate was 86.99%. This has increased by 0.14% compared to the same period the previous year. Non-ALN attendance at the same snapshot is 90.32%. This has increased by 0.11% compared to the same period the previous year.
- 11. In the current academic year to the end of April, the secondary sector ALN attendance rate was 80.44%. This has increased by 0.23% compared to the same period the previous year. Non-ALN attendance at the same snapshot is 87.80%. This has increased by 0.56% compared to the same period the previous year
- 12. Looking at various data trends we have established there is a concern regarding pupil attendance at school, on a Friday afternoon. Schools have reported a decrease in attendance on a Friday afternoon when compared to the morning session, ranging from 0.03% to 3.75%. (See appendices two & three)
- 13. A primary school example highlights attendance on a Friday afternoon 83.40%, however on a Tuesday morning session (their highest session), their attendance increased to 89.31% which is an increase of 5.91%.

- 14. A secondary school example highlights attendance on a Friday afternoon 80.07%, however, on a Monday AM (their highest session), the attendance increased to 88.02% which is a 7.95% difference.
- 15. We have recently met with schools to address the concerns regarding the decrease in pupil attendance on a Friday.
- 16. A national sharing good practice day has been organised for every Local Authority Education Welfare Service, which will include strategies to improve FSM and ALN. Neath Port Talbot County Borough Council is hosting the event, with 16 Local Authorities currently confirming their attendance with 150 education welfare staff.
- 17. Members will continue to be provided with regular reports the work being undertaken by the Education Welfare Service.
