##### **Application for the Grant of a Private Hire Vehicle licence**

##### **Purpose of the Report**

1. To consider an application for the grant of a private hire vehicle licence where the vehicle does not meet the requirements of the Taxi Licensing Policy.

##### **Executive Summary**

2. This is an application for the grant of a private hire vehicle licence.
3. The Council has adopted a Taxi Licensing Policy, which outlines the specifications that vehicles have to meet prior to licensing.
4. The policy specifies that vehicles shall be fitted with 4 doors. The vehicle being considered has 3 doors.

5. The Registration and Licensing Committee are being asked to consider whether the vehicle is suitable to be licensed.

### **Background**

6. The Council has adopted a Taxi Licensing Policy, which outlines the specifications that vehicles have to meet prior to licensing.
7. Appendix F – Private Hire Vehicle Specifications (condition 22) specifies that the vehicle shall be fitted with at least 4 doors.
8. The Council will use this policy as a basis for exercising its discretion when making decisions about licensing vehicles as private hire vehicles.

### **Officer Report**

9. The applicant made enquires with the Council to establish if a Volkswagen Crafter would be suitable for licensing.
10. Following inspection of the vehicle it was established that it does not meet the current policy as it only has three doors.
11. An application was submitted on the 4<sup>th</sup> of July by A & M Private Hire Ltd. for the grant of a private hire vehicle licence.
12. The vehicle is quite unique, as it is possible to fit two wheelchair users in at the same time and this is primarily why A & M Ltd. wish to licence it.
13. The Council has adopted a Taxi Licensing Policy which sets out general requirements and standards that must be met by applicants.
14. Appendix 1 of this report includes photos of the vehicle.
15. The applicant has confirmed they will bring the vehicle to the Civic Centre should members wish to view the vehicle themselves.
