### 1. **Chairpersons Announcements**

The Chair welcomed everyone to the meeting.

### 2. **Declarations of Interest**

The following Member made a declaration of interest at the start of the meeting:

Councillor A.Lodwig - Minute No. 6 – Application for a Hackney Carriage and Private Hire Driver Licence, Case 1 – as the Applicants representative was known to him. Cllr Lodwig felt this interest to be prejudicial, so left the meeting for the discussion and voting on this item.
