5. Application No. P2024/ 0626-60-61 Afan Road, Duffryn Rhondda, Neath Port Talbot, SA13 3ET

(At this point in the meeting, Councillor Jeff Jones reaffirmed his interest in this item, and took no part in the voting thereon.)

Officers made a presentation to the Planning Committee on this Application (Change of use of ground floor of 60-61 Afan Road, from retail unit (A1) to two x 1 bedroom holiday lets (C6)) as detailed in the circulated report.
