# **Hackney Carriage Vehicle Licensing**

#### **Purpose of the Report**

 To consider an application from Stuart Michael for a new hackney carriage vehicle licence, where the vehicle licence was not renewed prior to expiry.

# **Executive Summary**

- 2. This report is to consider an application from Stuart Michael for a new hackney carriage vehicle licence, where the vehicle licence was not renewed prior to expiry.
- 3. Officers only have delegated authority to grant a vehicle licence, where the vehicle meets the specifications set out in the Council's Taxi Licensing Policy.
- In this circumstance, the vehicle does not meet the required specifications as it is not wheelchair accessible; the application must therefore be determined by members.

#### **Background**

- 5. Hackney carriage vehicle licences are issued for 1 year, at the end of which it is necessary for the licence holder to apply to renew the licence. Where a licence expires, it cannot be renewed and it is necessary for a new application to be made.
- 6. All vehicles are required to meet the specifications as set out in the Council's Taxi Licensing Policy.
- 7. The Council's Taxi Licensing Policy states that vehicles that are to be issued with a new licence must be wheelchair accessible.
- 8. There are currently 267 hackney carriage vehicles licensed by the authority, 91 of which are wheelchair accessible.
- 9. Stuart Michael currently has 18 licensed vehicles, 3 of which are wheelchair accessible.

# **Officer Report**

- A letter was sent to Stuart Michael on the 1st February 2016 inviting him to apply to renew the licence of hackney carriage vehicle licence number HV072, Registration FR12 VVN.
- 11. No application was received and consequently the vehicle licence expired on the 25th April 2016.
- 12. A new application was received on the 28th April 2016. The application is effectively to re-licence the expired vehicle.
- 13. The vehicle passed the Council's vehicle examination on the 11th April 2016.
