Purpose of the Report

To provide information to members in relation to Licensing matters for the period 2015 – 2016.

Executive Summary

The Licensing Section is responsible for ensuring that the Council fulfils its statutory duty in respect of the administration and enforcement of licensing matters detailed in this report.

Background

The Licensing Section is responsible for the administration and enforcement of licences and registrations that are issued for the following functions:-

Taxis and Private Hire Vehicle

The Licensing Section issue licences for hackney carriage vehicles and drivers and private hire vehicles, driver and operators. Licensing Officers carry out inspection of licensed drivers and vehicles during routine stop checks in addition to the pre arranged inspections that take place at Tregelles court.
