## **Purpose of the Report**

1. To appoint three LA Governor Representatives to the new permanent governing body of Melin Primary School.

## **Background**

2. Members will be aware that Melin Primary School opened as an all-through 3-11 school on 1st September, 2016 replacing Melin Infant and Melin Junior Schools as one entity.

Members agreed in June, 2016 the creation of an Instrument of Government, which created a permanent name for the school and an incorporation date when a permanent governing body would take office of 1st November, 2016. The temporary governing body will continue until this date in its current form when their role and function will then come to an end. The current LA Governor Representatives on the temporary governing body are: Cllr. John Miller, Cllr. Sandra Miller and Cllr. Sheila Penry.

Members will be aware that LA Governor Representatives are appointed by the Council in priority order of: i) Elected Members representing wards in the catchment area of the relevant school or pupil referral unit; ii) Other elected members of the LA and iii) Persons who, in the opinion of the Council, would contribute to the well-being of the school or pupil referral unit.
