# Hackney Carriage Proprietor's Licence Renewal - Town Police Clauses Act 1847

# **Purpose of the Report**

 To consider an application from Mr Kamrul Hassan, to renew a hackney carriage proprietor's licence, where the licence has expired.

# **Executive Summary**

- 2. An application to renew a hackney carriage proprietor's licence, where the licence has expired, was received on the 10th July 2017; the licence expired on the 2nd July 2017.
- The Registration and Licensing Committee are being asked to determine whether the vehicle licence is capable of being renewed after the licence has expired.

# **Background**

- 4. Hackney carriage proprietor's licences are issued for 1 year, at the end of which it is necessary for the licence holder to apply to renew the licence.
- 5. In accordance with the Council's Taxi Licensing Policy (Paragraph 3.10 Renewal of Licence), where an application for renewal is made after the

licence expires, the Council will decide whether or not the licence is capable of being renewed taking into account how long after the expiry of the licence the application was made and the reasons why the licence was not renewed prior to the expiry; this is consistent with the approach in Exeter City Council V. Sandle [2011].

#### Case Law

- 6. In Exeter City Council V. Sandle [2011] it was determined that a hackney carriage licence was capable of renewal in the sense envisaged by the Local Government (Miscellaneous Provisions) Act 1976 s.60 after the expiration of the one-year period prescribed by the Town Police Clauses Act 1847 s.43.
- 7. There was no particular period in which it would cease to be capable of renewal but an application received two to three days late would require very good reasons for the delay for it to be entertained by a local authority; delay beyond that would require exceptional circumstances.

# Officer Report

- 8. A letter was sent to Mr Hassan on the 9th May 2017 inviting him to apply to renew the hackney carriage proprietor's licence in respect of licence HV114.
- 9. No application was received and consequently the licence expired on the 2nd July 2017.
- Mr Hassan attended the Licensing Office on the 10th July 2017 and submitted a renewal application for a hackney carriage proprietor's licence.

# New Hackney Carriage Proprietors Licence - Town Police Clauses Act 1847

## **Purpose of the Report**

- 1. To consider an application from Mr Kamrul Hassan for a new hackney carriage proprietor's licence where the vehicle does not comply with the Council's Taxi Licensing Policy.
- 2. Note: This report will only need to be considered in the event that members determine that the renewal of the hackney carriage proprietor's licence is not capable of being renewed. The renewal application is dealt with in a separate report.

# **Executive Summary**

- 3. An application for a new hackney carriage proprietor's licence for a Toyota Avensis, was submitted on the 10th July 2017.
- 4. The vehicle specified in the application, does not comply with the requirements stipulated in the Council's Taxi Licensing Policy (Appendix E - hackney carriage vehicle specifications) as it is not wheelchair accessible.

5. Officers only have delegated authority to grant a hackney carriage proprietor's licence, where the vehicle specified in the application, complies with the specifications set out in the Council's Taxi Licensing Policy.

# **Background**

- 6. The Council has adopted a Taxi Licensing Policy which at Appendix E "hackney carriage vehicle specifications", sets out the requirements that the Licensing Authority expects will be met before a hackney carriage proprietor's licence will be issued.
- 7. One such specification is that all new hackney carriage proprietors' licences must be for a vehicle that is wheelchair accessible.
- 8. The purpose for requiring all new vehicles to be wheelchair accessible is to ensure that a mixed fleet of both wheelchair accessible and non-wheelchair accessible vehicles are available for members of the public to use.
- 9. There are currently 259 proprietors' licences, 86 of which are for vehicles that are wheelchair accessible and 173 for vehicles which are non-wheelchair accessible.

# Officer Report

- An application for a new Hackney carriage proprietor's licence for a Toyota Avensis, was submitted by Mr Kamrul Hassan on the 10th July 2017.
- 11. Mr Hassan previously held a hackney carriage proprietor's licence for this vehicle, however the licence expired on the 2nd July 2017, as an application for its renewal was not submitted prior to the expiry.
- 12. Had Mr Hassan applied for the renewal of the previous proprietor's licence prior to the expiry, it would have been renewed under officer delegated authority.
- 13. Mr Hassan's new application is for a Toyota Avensis, which is not wheelchair accessible and consequently does not comply with the Council's Taxi Licensing Policy.

## **Equality Impact Assessment**

15. There is a right of appeal to the Crown Court against a decision to refuse to grant a new hackney carriage proprietor's licence.
