Matter for Decision

Wards Affected: All

Active Travel (Wales) Act – Consideration of: the requirements of the Active Travel (Wales) Act 2013; the revised Existing Route Map (ERM) for Neath Port Talbot; the Consultation Draft Integrated Network Map (INM) for Neath Port Talbot; and the publication / consultation procedures to be implemented.

Purpose of the Report

To consider the requirements for the delivery of the Active Travel (Wales) Act 2013; to agree the *revised* Existing Route Map (ERM) for Neath Port Talbot; to agree the *Consultation Draft* Integrated Network Map (INM) for Neath Port Talbot; and to authorise the publication / consultation procedures to be implemented.

Executive Summary

- The Active Travel (Wales) Act 2013 (*the Act*) makes it a legal requirement for the Council to map and plan for suitable routes for active travel within the following settlements: Neath, Port Talbot, Pontardawe, Croeserw, Cymmer, Brynamman, Gwaun Cae Gurwen, Blaengwrach, Glynneath, Cwmafan, Seven Sisters and Resolven.
- Active Travel means walking and cycling for everyday short-distance journeys, such as journeys to school, work, or for access to shops or services. Active travel does not include journeys purely made for recreation or social reasons.
- The Act requires local authorities to prepare, publish and keep under review an Existing Route Map (ERM) and an Integrated Network Map (INM).

- The Council's ERM (first approved in 2016) has been reviewed and a draft INM has been prepared with sets out the Council's aspirations for the next 15 years, identifying improvements to existing routes or new routes that the Council considers should be developed and added to the active travel network. The Council is required to consult on both maps to determine whether they are fit for purpose.
- This report seeks endorsement of the revisions to the ERM, the Consultation Draft INM and the approval of the publication and consultation arrangements to be implemented.

Background

- In November 2013, the Welsh Government introduced the Active Travel (Wales) Act 2013 (*the Act*) which makes it a legal requirement for local authorities in Wales to map and plan for suitable routes for active travel within settlements specified by Welsh Government.
- Those settlements in Neath Port Talbot include: **Neath**, **Port Talbot**, **Pontardawe**, **Croeserw**, **Cymmer**, **Brynamman**, **Gwaun Cae Gurwen**, **Blaengwrach**, **Glynneath**, **Cwmafan**, **Seven Sisters** and **Resolven**.
- Active Travel means walking and cycling for everyday short-distance journeys, such as journeys to school, work, or for access to shops or services. Active travel does not include journeys purely made for recreation or social reasons.
- The Act requires local authorities to prepare and publish the following two maps:
 - Existing Route Map (ERM) primarily intended to inform the public of the existing routes in the County Borough that the Council considers suitable for active travel meeting Welsh Government standards; and
 - Integrated Network Map (INM) required to set out the Council's aspirations for the next 15 years, identifying improvements to existing routes or new routes that the Council considers should be developed and added to the network. The INM is therefore mainly a tool to enhance the forward planning of active travel and to support infrastructure development planning.

Existing Route Map (ERM)

- 11 The Council prepared, consulted upon and submitted its ERM to the Welsh Government early in 2016. Following a period of review, the Council subsequently received Ministerial approval on 12th August 2016.
- The ERM does not show all walking and cycling routes across the County Borough, it only indicates those existing routes that provide for active travel journeys meeting the requirements set by Welsh Government.
- In accordance with Welsh Government guidance, and in parallel to the work on the emerging INM, the Council's ERM has been kept under review. This review has identified a limited number of additional routes that have warranted consideration for inclusion and consequently, these routes have been audited and scored against the design guidance in the Act.
- The proposed revised draft ERM for Neath Port Talbot therefore includes the following four additional routes, the details for which are shown in **Appendix 1** all other routes included on the approved ERM remain unchanged:
 - NPT-NEA-C00120: cycle route from Crymlyn Parc to Serecold Avenue, Skewen;
 - NPT-PON-C0050: cycle route from Bryn Morgrug to Valley Route;
 - NPT-PT-C00170: cycle route from Port Talbot Parkway to Harbour Way; and
 - NPT-PT-P0200: pedestrian route from Port Talbot Bus Station to Green Park.

Integrated Network Map (INM) – Methodology

- The methodology applied to the preparation of the draft INM for Neath Port Talbot has been developed in collaboration with neighbouring Local Authorities, in order to ensure that a consistent approach is taken across administrative boundaries.
- To date, the draft INM has been informed and based on the outputs of the following three work stages:
 - Stage 1 Information Gathering & Journey Mapping;

- Stage 2 Route Assessment / Feasibility; and
- Stage 3 1st Consultation (Jan-Feb'17).

Stage 1 – Information Gathering & Journey Mapping

17 Building on the ERM exercise, information has been collected from a variety of sources to establish the active travel journeys that people are already making within Neath Port Talbot. Trip departure (e.g. residential areas) and destination points (e.g. trip attractors, employment, health care, education) were mapped to establish the main 'desire lines' that exist for both pedestrian and cycle routes within each settlement.

Stage 2 – Route Assessment / Feasibility

To convert the identified 'desire lines' into proposed routes, the 'desire lines' have been assessed / audited to determine their feasibility as active travel routes. Suitability of the routes in terms of comfort, attractiveness, accessibility / coherence and safety were all considered along with potential improvements that could be made.

Stage 3 – 1st Consultation (Jan-Feb'17)

- 19 Earlier this year, an initial opportunity was taken to conduct a short, focussed public / stakeholder consultation to determine what active travel journeys are currently made; what perceived or actual barriers exist that limit the ability to make active travel journeys; and which routes are considered desirable to be included on the INM.
- The public, delivery partners, 'seldom heard groups' and children / young people were specifically targeted with a variety of engagement methods employed, including an online survey, a community event and school 'show of hands' surveys.
- These efforts supplemented work that officers had already carried out in respect of community events and visits to a number of schools across the County Borough, where pupils had been actively engaged in workshop discussion about their journeys to school and other activities.

Neath Port Talbot INM – Consultation Draft

The Consultation Draft INM for Neath Port Talbot is presented in **Appendix 2**. Consisting of a schedule of routes listed by settlement along with a series of location maps, this 15-year forward plan shows

- routes where either improvements could be made or where new routes could be developed.
- 23 Members should note that the INM is an aspirational document and not a commitment to deliver. Notwithstanding this point, the INM will be an important document for the Council and should be considered as part of the planning decision making process so that the aspirations are realised as part of ongoing development, either directly or by means of financial contributions from developers.
- In terms of an overview, the draft INM includes the following (these are in addition to the routes included on the ERM):
 - Total number of routes **100**;
 - Number of routes by type **58 cycling** and **42 pedestrian**;
 - Number of routes identified as having potential for delivery in the short term – 56; and
 - Number of routes identified as long term / aspirational 44.

Consultation

- The Council is required to formerly consult on both the proposed additions to the ERM and draft INM with the purpose of the consultation to determine whether they are fit for purpose.
- In accordance with national guidance, the consultation will be held over a period of 12 weeks, commencing in late June. The aim will be to reach all appropriate audiences required by the delivery guidance including children / young people and those groups with protected characteristics under the Equalities Act 2010.
- The consultation will be promoted and facilitated through a variety of means:
 - A Press Release will be issued;
 - A Questionnaire will be provided to gather data on the journeys that people are making on existing routes, feedback on the quality of existing infrastructure and/or any issues or areas for improvement, and feedback on the usefulness of potential routes;
 - The Council's website will provide all relevant information and documentation, including direct links to an interactive online survey;
 - Information will be made available at the Civic Centres; and

- Correspondence will be sent to all relevant individuals, stakeholders, organisations and schools (Primary and Secondary) describing the purpose of the consultation, identifying where more information can be obtained and how representations can be made.
- In accordance with the Council's Welsh Language Scheme all publicity / communication will be bilingual. Responses will be in the language used by the respondent.
- The maps will be available for purchase at a reasonable charge. In common with previous practice, it is suggested that the price be based on the cost of printing together with post and package at the prevailing cost. Electronic copies will be made available at no cost.

Timetable

- 30 The timetable for implementation is as follows:
 - Revised ERM and INM Consultation (12 weeks) Monday 26th June to Monday 18th September 2017;
 - Cabinet Board approval of Consultation Report, Final INM & Prioritisation – October 2017; and
 - Submission of Revised ERM and INM to Welsh Government 3rd November 2017.

Financial Impact

- Funding to create and consult on these maps has been provided by the Welsh Government as part of the Local Transport Fund. Costs will therefore be accommodated within existing budgets.
- In respect of the delivery of schemes, it should again be emphasised that as the INM is an aspirational document and not a commitment to deliver, there are consequently no financial implications for the Council in the longer term. For those schemes that are delivered, it is expected that they will primarily be funded as part of ongoing development, either directly or by means of financial contributions received from developers.

Equality Impact Assessment

In order to assist the Council in discharging its Public Sector Equality Duty under the Equality Act 2010, an Equality Impact Assessment

Screening Exercise has been carried out. The Screening Exercise concluded that there is no requirement to carry out an additional separate exercise.

Workforce Impacts

34 There are no workforce impacts in respect of this report.

Legal Impacts

The report addresses the legal requirement for the Council to map and plan for suitable routes for active travel within certain settlements specified by Welsh Government.

Risk Management

The Council will be in breach of its legal requirement to prepare and publish Active Travel maps should there be a failure to implement the proposed recommendations.

Recommendation

- That having considered the report, it is resolved to make the following recommendations for approval:
 - The revised ERM summarised in the main body of the report and presented in **Appendix 1** be agreed as forming the basis of consultation.
 - The INM summarised in the main body of the report and presented in **Appendix 2** be agreed as forming the basis of consultation.
 - 3. The engagement and consultation arrangements as set out in the report are implemented.

Reasons for Proposed Decision

- 38 The recommendations are needed to:
 - 1. Ensure compliance with the requirements of the Active Travel (Wales) Act 2013.
 - 2. Authorise the public consultation exercise on the revised ERM and INM and related tasks.

Implementation of Decision

The decision is for immediate implementation and the relevant Scrutiny Chair has agreed to this course of action.





Settlement: Neath



Settlement: Port Talbot










INM Map 1: Lower Brynamman & Gwaun Cae Gurwen





Section 1: Key Points

Economic Development

In 2016/17 the Economic Development Team received a higher volume of requests for support from local businesses than the previous year. These requests in general were of a positive nature with many considering investing in expansion and growth which has helped attract new private sector investment while supporting the creation of new employment and the safeguarding of existing jobs within the County Borough. Consequently, despite L(ED) 1 outputs being lower that what was achieved last year, the Team has actually processed more funding applications than the previous year, which should be viewed as positive.

The team also played a major role in securing Enterprise Zone status for Port Talbot Waterfront which is already providing significant financial benefit to local businesses through Business Rates Relief. Continued partnership working with Welsh Government should help further promote economic growth and job creation in the area.

Providing advice and support to individuals considering starting up in business is also a priority. This year there has been a significant increase

in the number of local residents considering self-employment and this is reflected in the popularity of the Enterprise Club that the Team runs from the Sandfields Business Centre and the significant increase in the outputs reported for the L(ED)2.

In addition, the team continues to work in partnership with key business support organisations to provide support to the many local businesses looking for advice on issues such as property, rates relief, local contract opportunities, tendering, events, etc. and this has had a positive impact on performance as outputs for L(ED)3 significantly exceed those achieved last year.

Planning

A strong fourth quarter performance and consistent implementation of new internal processes relating to "invalidity" has continued the significant improvement in the average time taken to validate applications (PLA/M001) in addition to the time taken to determine applications from received date to determination (PLA/M002).

Overall performance remains consistent with 2015/16, with a renewed commitment to "front-loading" discussions on applications, and the ongoing review of processes – having regard to the new legislative changes – seeking to further improve efficiencies, reduce bureaucracy and reduce delays. In addition, a new Senior Planner appointment is being progressed as recognised in the FFP to provide additional resilience to enable increased focus on delivery of large scale, controversial or complex developments within statutory or agreed timescales.

These actions should, in turn, improve our overall performance going forward having regard to the 8 week statutory deadlines.

Building Control

It is regrettable to report a slight drop in performance in relation to BCT007 in comparison with the figures reported last year.

The drop in performance is attributed to the sudden and unexpected departure of two experienced members of staff. With the recruitment process for a replacement now complete and training of the new members of staff ongoing, the section is able to report that the performance has improved over the course of this year.

Furthermore despite the staffing issues referred to, the performance in relation to BCT/004 (SID) when compared to both last year and to the third quarter of this year is one of improvement.

It must be stressed that at no time have any legal targets been missed.

Housing – Private Sector Renewal

External factors such as the local housing market has a significant imapact on the number of properties brought back in to use. The department is making progress and proactively dealing with long term empty properties based on a risk rating tool that we have developed. An enforced sales policy has also been approved and is being used to bring back into use a number of long term difficult empty properties throughout the County Borough.

The properties requiring a HMO licence have remained the same, however the percentage has slightly increased due to the number of known Houses in Multiple Occupation reducing from 448 to 442.

We have seen a slight improvement in PSR/009b, and PSR/002 is within 5% of quarter 4 2015/16. The decrease in performance for PSR/009a can be attributed to the total end to end time of the grants in question as a result of the increased demand for extensions.

Public Protection

94.92% of food establishments were "broadly" compliant with food hygiene standards, marginally up on last year's performance within the same period of 92.7%. The percentage of high risk businesses inspected for food hygiene has again achieved 100%, which is a reflection of the priority given to this service. The percentage of high risk businesses inspected by Trading Standards has decreased from 100% to 95.6% as the department is detecting more complex and significant infringements in this area and has experienced some staffing issues.

The percentage of significant breaches that were rectified by intervention during the year has increased for Trading Standards (79.2% in comparison to 73.5%), but dropped for Animal Health (81.8% in comparison to 100%). Rectification was achieved through the issuing of written warnings, cautions or the provision of formal advice to traders. Investigations are ongoing in relation to outstanding breaches.

The percentage of identified new businesses which were subject to a food hygiene risk assessment visit is also higher than last year (97% compared to 92%). This improvement is as a consequence of the quality of the advisory service provided to new businesses to assist them with future compliance.

Asset Management

There has been a significant reduction in the number of buildings that NPT manage due to:

- Several schools being renewed and existing school buildings demolished or sold.
- A large number of community centres, bowling greens and pavilions, changing rooms, etc. leased out to community groups.
- Further reduction in day centres and social service buildings.

This has resulted in a reduction of backlog maintenance of circa £20M (From £132.6M to £111.8M). Further reductions are expected when vacant / surplus buildings are disposed of.

Survey figures are usually adjusted using BCIS (Building Cost Information Service) maintenance indices, supplied by City and County of Swansea (as agreed with Data Unit Wales), unfortunately, the maintenance indices were not available this year (C&C of Swansea no longer subscribe to this service). Several other BCIS indices were consulted and an on average, it was determined that costs have risen by circa 3% over the last year, therefore, in the absence of the maintenance index for March 2017, a 3% increase was applied to 2016/17 costs. It is expected that Data Unit Wales will have made alternative arrangements for next year's KPI submission.

For example, recycling, educational attainment, sustainable development, etc. This information is required and reported nationally, validated, and published annually.

(SID) Service Improvement Data - can be used by local authority services and their regulators as they plan, deliver and improve services.

All Wales - The data shown in this column is the figure calculated using the base data supplied by all authorities for 2015/2016 i.e. an overall performance indicator value for Wales.
