1. MEMBER'S COMMUNITY FUND

Decision:

That the Member's Community Fund be formally adopted, and fully operational during 2018/19, as detailed in the circulated report.

Reason for Decision:

To ensure that the positive outcomes associated with this investment can be wholly realised in Neath Port Talbot.

2. FORWARD WORK PROGRAMME 2018

Decision:

3. THIRD SECTOR GRANTS SCHEME

Decisions:

- That the Director of Finance and Corporate Services and the Assistant Chief Executive and Chief Digital Officer be authorised to commence consultation on the proposed revisions to the Third Sector Grants Scheme, the consultation to run from 23 May to 15 August, 2018;
- 2. That the Director of Finance and Corporate Services and the Assistant Chief Executive and Chief Digital Officer be authorised to explore with strategic partners, the merits/otherwise of the current arrangements and report back to Members accordingly.

4. LOCAL GOVERNMENT REORGANISATION

Decisions:

This majors on the points in paragraphs 11-23 of the circulated report, also including the "tests" outlined; and 2. 5. WELSH LANGUAGE PROMOTION STRATEGY

Decisions:

That the Welsh Language Promotion Strategy, as contained in Appendix 1 of the circulated report, be put out to Consultation for a four week period, subject to the following amendment to the last sentence on Page 98 reading "to slow down the decline in numbers and percentages of Welsh speakers. Losing this natural endowment would have a huge psychological impact on the rest of the County Borough";
- 2. That the Consultation responses be considered by the Welsh Language Promotion Strategy Task and Finish Group with the final Welsh Language Promotion Strategy being submitted to Cabinet for approval.

Reason for Decisions:

To ensure that Neath Port Talbot complies with the requirements of the Welsh Language Standards Regulations 2015.
