1. **MINUTES OF PREVIOUS MEETING**

The minutes of the meeting held on 25 October, 2019, were approved.

2. **FORWARD WORK PROGRAMME 2019/2020**

The Forward Work Programme was noted.

3. **WASTE MANAGEMENT UPDATE**

Members received a presentation and update on Waste Management in Neath Port Talbot.

In response to member's queries officers stated that food waste was still being placed in some residents wheeled bins, it was explained that residents needed to increase the amount of recycled food waste in the correct receptacle.

A discussion took place around the monitoring of the side waste restriction exemption scheme for non-recyclable waste. It was highlighted that the number of residents applying for exemptions had risen when side waste collections ended. Officers explained that Side Waste Officers had individual rounds, officers monitor and check waste collections and contact residents who present incorrect side waste to help them reduce the amount of refuse being presented.

Officers informed members that Neath Port Talbot had one of the most successful enforcement teams in Wales and would continue to monitor levels of fly-tipping throughout the county borough. It was noted that a fly-tipping update report would be brought back to the Scrutiny Committee on 17 January 2020.

It was noted that when the new Waste National Strategy was published, Welsh Government would look at electrical waste (rare materials), for a possible future kerbside collection.

Officers highlighted that the Welsh Government had set a target for Wales to recycle 70 percent of its waste by 2025, and achieve zero waste by 2050.

#### Road Safety Strategy Update 2015-2020

#### Purpose of Report:

To report on NPTCBC's current position against the targets set within our Road Safety Strategy 2015–2020.

#### Executive Summary:

During the life of our current Road Safety Strategy 2015–2020, the following has been achieved:

Latest available quantified data shows significant reductions across the key Welsh Government road safety indicators when measured against the 2004–2008 baseline data.

- **Child casualties (0-15 years)** - 93% reduction against a Welsh Government target of 40% reduction.
- **Pedal cyclist casualties (all ages)** - 85% reduction against a Welsh Government target of 25% reduction **Young Drivers (16-24 years)** 75% reduction against a Welsh Government target of 40% reduction on 2004 - 08 baseline data.

- **Motorcyclists (all ages)** - 64% reduction against a Welsh Government target of 40% reduction.
- **Older Drivers (75 years and over)** - 96% reduction against a Welsh Government target of 25% reduction.

### **Background:**

Road Safety is a statutory responsibility for Local Highway Authorities with the Road Traffic Act 1988 Section 39 placing a duty to prepare and carry out a programme of measures designed to promote road safety.

Welsh Government produced their Road Safety Framework for Wales in July 2013 with the then Welsh Government Minister for Economy, Science and Transport, setting National Targets for local Authorities to be achieved by 2020.

In response to the WG Framework our Road Safety Strategy 2015–2020 was developed and sought to reflect NPT local road safety requirements, identified through an evidence based approach to road safety education and engineering; taking into account the most up to date recommendations, guidance, targets and strategies available.

In delivery of the Strategy, the following education/training has been delivered across the County:

- **School Education** Primary/Secondary over **35,000 pupils** have taken part in our road safety education programme.
- On road 12 week **Child Pedestrian Training** programme delivered to **3,500** six year olds.
- Walk to School/**Active Travel** Events with **2,500** pupils having taken part.
- In line with the **WG Learner Travel Wales** Guidelines, our newly appointed Learner Travel Officer (first in Wales) has carried out **131 assessed routes**, for 73 schools across the County. They have engaged **1,200** pupils in a transitional education programme producing bespoke travel journey information to each pupil for their feeder comprehensive school to assist with their journey planning.



- **Cycle Training** delivered to over **9,800 pupils**, ranging from cycle maintenance through to Level 1 and Level 2 on road training for Year 6 pupils.

### **Driver/Rider Training:**

In line with WG target for casualty reduction we have delivered further training to over **1,000 newly qualified drivers**, a further **1,000 motorcyclists** have also received DVSA (Driver Vehicle Standards Agency) accredited training, with **180 mature drivers** partaking in our Drive for Life scheme; all resulting in an upskilling of these identified vulnerable driver/rider groups and a sharp decline in killed/seriously injured statistics as detailed above.

### **Professional Driver Training: (Income generation)**

Over **1,800 of our in house** drivers have received accredited training from CPC (Certificate of Professional Competence) driver licence requirements, through to B+E, C1 and D1 Licence acquisition.

The Road Safety Manager has been heavily involved in the current WG Framework review 2013–2020. We are therefore awaiting WG new five year Framework due later this year, before producing our next Strategy for consideration.
