REVOKING THE RIGHTS OF WAY TEMPORARY CLOSURES DUE TO COVID-19

Purpose of the Report

To seek approval of Neath Port Talbot County Borough Council (“the Council”) to revoke the temporary closures on a number of public rights of way closed under the (Health Protection (Coronavirus Restrictions) (Wales) Regulations 2020 due to Covid-19.

Executive Summary

The Council currently has 17 Public Rights of Way (PROW) closed temporarily as a response to the introduction of the Health Protection (Coronavirus Restrictions) (Wales) (Amendment) Regulations 2020 in March 2020.

Following the publication of the 7th edition of the Regulations (The Health Protection (Coronavirus Restrictions) (Wales) (Amendment) (No. 7) Regulations 2020) on the 3rd July 2020, this report seeks to set out the Council’s response to address these amendments.

Background

With the introduction of the Health Protection (Coronavirus Restrictions) (Wales) Regulations 2020 and in order to enforce social distancing and to stem the spread of Covid-19 to protect the public health and safety of our

communities, the decision was taken to temporarily close a total of 17 Public Rights of Way (PROW) within the County Borough, where there was considered to be a heightened risk of the disease being spread. The decisions were taken in consultation with the Leader, Deputy Leader, Cabinet Member for Regeneration and Sustainable Development and Cabinet Member for Community Safety and Public Protection.

A list of the closed paths are detailed below along with the closure dates, all details of which were publicised on the Council's website.

On the 3rd July 2020 the Welsh Government published The Health Protection (Coronavirus Restrictions) (Wales) (Amendment) (No. 7) Regulations 2020, which contained a number of amendments, including (*but not limited to*) revoking of the requirement in the principal regulations not to leave the area local to the place where the person is living unless there is a reasonable excuse; rationalising the different restrictions on gatherings indoors and outdoors; and clarifying that it is a reasonable excuse to gather together with others to participate in activities organised at outdoor visitor attractions.

Whilst noting that the Regulations relating to Public Rights of Way have not specifically changed, in light of the restrictions on movement being lifted and the push to open up the tourism industry, it is proving difficult to continue to justify and enforce the closure of those PROW currently closed

due to Covid-19. Furthermore, given that the 2 metre social distancing rule is also highly likely to be reduced shortly in Wales, this makes it more feasible for social distancing to take place within the PROW.

Consequently, it is therefore now proposed that the closure orders be rescinded and the aforementioned footpaths opened up for public use.

It is also worth noting that many other Local Authorities have started to revoke their orders as well and it is anticipated only a few temporary closures in Wales will remain in force by next week.
