# 1. <u>Mayor's Announcements</u>

The Mayor was pleased to inform Council that Neath Port Talbot County Borough Council had received a number of nominations at the recent APSE awards:

- Best Overall Council for the Year
- Best Collaborative Working Initiative with the Public and third sector
- Best Service Team Facilities Management and Building
  Cleaning Service
- Best Service Team Cemetery and Crematorium Services
- Best Public/Private Partnership Working Initiative

And the Council had won the Best Public/Private Partnership Working Initiative for the innovative council scheme – centred around an online directory – NPT Buy Local. The Mayor thanked all of the staff for the work they do for Neath Port Talbot and the staff nominated.

The Mayor congratulated Harri Jenkins, who won a bronze medal in the 100 metres at the Tokyo Paralympics, as well as Joe Brier and Daniel Jervis who were selected to represent Wales, Great Britain in the Tokyo Olympics.

Council also congratulated Councillor Saif Rahaman and family on the birth of a son.

# 4. Corporate Plan Annual Report 2020/2021

# 5. Place Making Charter

# 6. Gambling Act 2005 - Review of Gambling Policy

The Chair of the Licensing Committees gave Members of Council an overview of the circulated report, and explained that once again, it was not proposed to allow the issue of Casino licenses within Neath Port Talbot.

**RESOLVED:** That having given due regard to the Integrated Impact Assessment, approval be granted to consult on the revised Gambling Policy.

# 7. <u>Agreement of Lay Member Recruitment Programme for</u> <u>Governance and Audit Committee</u>

The Head of Legal Services gave an overview of the circulated report.

- **RESOLVED:** 1. That the changes to the constitution for the Governance and Audit Committee from May 2022 to comprise of 8 elected members and 4 lay persons, with a lay chair being appointed by the Governance and Audit Committee be approved.
  - 2. That Mrs Joanna Jenkins be approved as a lay person of the Governance and Audit Committee from May 2022 for a further period of five (5) years.
  - That a recruitment exercise to appoint 3 lay persons to the Governance and Audit Committee be approved.
  - 4. That the eligibility criteria, application form and advert as set out at Appendix 1, 2 and 3 of this report be approved for use in the recruitment process.
  - 5. That a selection panel be established as set out in the circulated report.
- 6. That a report be brought back to Council following the conclusion of the selection process for members to consider the views of the Selection Panel and consider the appointment of lay persons.
