Culture and Heritage Strategy Report

Members received an update in relation to the culture and heritage position within Neath Port Talbot, as detailed within the circulated report.

It was noted that the Council was currently not in a position to submit an expression of interest for the current round of the City of Culture bid. However, endorsement was sought to undertake work in developing a culture and heritage strategy for the county borough that could subsequently be used to support the investment decisions and future bids for funding.

Members queried whether the levelling up fund would provide any resource to help with capacity in terms of the work around producing a Culture and Heritage Strategy. Officers confirmed that they would provide this information outside of the meeting.

Members shared their knowledge on the heritage and culture within their local areas. They highlighted their concern as to why the Council felt they were not in a position to provide an expression of interest, considering the amount of culture and heritage that was within Neath Port Talbot. Following this, officers emphasised the further need to produce a Culture and Heritage Strategy.

Following scrutiny, the Committee were supportive of the Recommendations to be considered by cabinet board.

Report Title: ADMISSION/CAPACITY IN SCHOOLS

Purpose of the Report:

At the request of Members as part of their forward work programme this report provides Members with information and data in relation to the admission and capacity of pupils and placements to Neath Port Talbot schools.

Executive Summary:

The number of admission applications for pupils entering or moving schools in Neath Port Talbot has increased in recent years. The vast majority of applicants are offered their first choice of school with just 1.45% of applicants being offered their second preference of choice. More than three-quarters of applications made are now online.

Background:

Members of the Scrutiny Committee have asked officers to provide a report outlining the results of the annual admission round of pupils entering Neath Port Talbot schools.

Members will be aware that each year permission is sought from Education, Skills and Culture Cabinet to firstly carry out a consultation process with interested parties regarding the Council's Admissions Policy for the year ahead and then in again to the responses to the consultation Cabinet is asked to approve an annual Admissions Policy.

Whilst today marks the first day of the 2021/22 academic year, the admission round to enable parents apply for a school place for their child for the academic year 2022/23 will commence in a matter of weeks. Officers will also be starting the process of drafting the Admissions Policy for the 2023/24 academic year over the next few months for submission to Cabinet for consideration prior to Christmas.

Over the past three years the service has been rolling out the ability for parents to apply for a school place online in place of the completion of a traditional paper application form. This academic year saw the final phase of digital rollout with the inclusion of nursery admission applications. 884 applications were received, with 658 being made online (74.4%).

Academic Year 2021/22

Members have previously requested data in relation to the number of pupils who were offered their first and second place choice of school within the county borough and also to be provided with information in relation to school capacity.

- Number of applications received: 2,965
- Number allocated first choice preference: 2,922 / 98.55%

- Number allocated second choice preference: 43 / 1.45%
- Number of independent appeals: 7
- Number of successful appeals: 2
- Number of applications processed online: 76.3%

A list of individual schools along with the capacity and pupil admission number is attached as Appendix A. Members should note that whilst these figures represent the overall surplus or over capacity of the school as a whole, admission might be still be denied based on an application to a particular year group which is at full capacity. Interpretation of these figures comes with a health warning that they can fluctuate on a daily basis depending on the fluid movement of pupils.

In addition to the application figures above, the Admissions Team also process in-year transfers. These are applications for admissions to a school that are outside of the normal admission round, usually mid-year transfers. Numbers under this category have increased substantially in recent years. For the 2020/21 academic year, despite the Covid pandemic and restrictions placed on individuals, some 716 applications were processed for pupils to move schools. Although today is the first day of the new academic year, already the service has received and processed 167 transfer requests. All-bar 5 have been offered their first choice of school.

The majority of reasons provided on the application forms for wishing to change their child's school mid-year are relating to accommodation moves within the county and new families moving into the Neath Port Talbot area.
