Craffodd y Pwyllgor ar yr eitemau canlynol ar agenda Bwrdd y Cabinet:

Cyflwynwyd adroddiad i'r aelodau mewn perthynas â Chynllun Llesoli Wenyn Castell-nedd Port Talbot.

Dyweddodd swyddogion fod y cynllun hwn yn cynnig newid trefn reoli a thorri ymylon sy'n eiddo i'r cyngor, er mwyn annog glaswelltiroedd blodau gwylt i ddatblygu, a fydd hefyd yn cyd-fynd â'r gofynion a nodir yn Neddf yr Amgylchedd (Cymru) 2016, Cynllun Dyletswydd Bioamrywiaeth y cyngor a Chynllun Gweithredu Adferiad Natur Castell-nedd Port Talbot.

Nodwyd bod y seminar diweddar ar gyfer yr holl aelodau a gynhaliwyd i drafod y pwnc hwn yn ddefnyddiol iawn ac yn caniatáu i'r aelodau roi eu mewnbwn; Ystyriodd swyddogion lawer o'r sylwadau a'r awgrymiadau a wnaed.

Pwysleisiodd y Pwyllgor bwysigrwydd cynnal y defnydd o fannau gwyrdd ar gyfer amwynder, yn enwedig yn yr ardaloedd trefol; roedd

yn bwysig cael cefnogaeth gan y gymuned a chael ymgysylliad cymunedol cadarn. Soniwyd bod Tai Tarian yn berchen ar hanner yr ardaloedd gwyrdd ac yn eu rheoli a bod yr hanner arall yn eiddo i'r cyngor ac yn cael eu rheoli ganddo; roedd angen cydlyniad rhwng y ddau grŵp er mwyn sicrhau bod cymysgedd priodol rhwng cadw mannau amwynder a ddefnyddiwyd yn aml, a chyflwyno'r gwelliannau pwysig i fioamrywiaeth.

Rhannodd yr aelodau stori arfer da gan Tai Tarian, lle'r ymgysyllton nhw â chymdogion mewn ardal, mewn perthynas â newid man gwyrdd, ac roeddent wedi gallu gwneud mân newidiadau i'w cynlluniau gwreiddiol i ganiatáu i weithgareddau cymunedol ddigwydd yn y man gwyrdd, yn ogystal â chael yr ychwanegiadau bioamrywiaeth angenrheidiol; roedd ymgysylltu â'r cyhoedd yn bwysig iawn gan ei fod yn rhoi dealltwriaeth o sut roedd y gymuned yn defnyddio lleoedd.

Cadarnhaodd swyddogion fod mannau amwynder yn hanfodol bwysig yn y gymuned, a'i bod hefyd yn bwysig sicrhau bod y cyhoedd yn ymwybodol o'r cynllun hwn fel eu bod yn deall y rhesymau pam yr oedd angen gwelliannau i fioamrywiaeth; byddai cyfathrebu a brandio'r cynllun hwn yn hanfodol, a gwnaed awgrymiadau mewn perthynas â ffyrdd o'i hyrwyddo i'r cyhoedd

Soniwyd bod aelodau'r Tîm Bioamrywiaeth wedi anfon llythyrau at Gynghorwyr ac wedi cynnal cyfarfodydd unigol â nhw yn eu Wardiau i drafod ardaloedd penodol, gan fod anghenion penodol gwahanol ar draws yr amrywiaeth o fannau awyr agored.

Hysbyswyd yr aelodau fod angen i'r cyngor sicrhau bod ei sefyllfa a'i weithdrefnau wedi'u sefydlu, ac yna byddai staff yn trafod y mater hwn â gwahanol sefydliadau i sicrhau eu bod eu hymagwedd yn cyd-fynd ag ymagwedd y cyngor. Ychwanegodd swyddogion mai diogelwch fyddai'r flaenoriaeth gyntaf yn y gwaith a wneir.

Gofynnwyd a fyddai'r cynllun yn cael ei ehangu i ardaloedd tir llwyd a thir diwydiannol nas defnyddir. Esboniodd swyddogion mai'r ffocws presennol oedd edrych ar yr ymylon presennol ar dir sy'n eiddo i'r cyngor; byddai'r cynllun yn cymryd peth amser i symud drwy'r gwahanol feysydd, gan fod Swyddogion yn awyddus iddo weithio'n effeithiol. Fodd bynnag, cadarnhawyd y gallai fod yn bosib ymchwilio i'r ardaloedd tir llwyd i ddod â blodau gwylt yn ôl iddynt; gallai swyddogion drafod cynlluniau i archwilio'r ardaloedd hyn a nodi a oedd unrhyw fanciau hadau presennol y gellid eu hailhadu er mwyn iddo dyfu'n ddôl blodau gwylt. Ychwanegwyd bod y cyngor am osgoi

cyflwyno rhywogaethau anfroddorol a chymysgeddau hadau gan fod elfen gost i hynny, ac roedd am annog rhywogaethau brodorol i dyfu. Byddai swyddogion yn cysylltu â Chydlynnydd y Bartneriaeth Natur Leoli drefnu trafodaeth â'r aelod â diddordeb am yr ardaloedd tir llwyd yr oeddent yn cyfeirio atynt; yna gellid cynnwys yr ardal ar y map, ac os yw'r ardal yn dir sy'n eiddo i'r cyngor, gellid cynnal arolwg i gael dealltwriaeth o'r ardal a'r hyn y gellid ei wneud i wella bioamrywiaeth.

O ran canfyddiad y cyhoedd, nodwyd bod angen dosbarthu negeseuon clir pan fydd cynlluniau'n cael eu llunio, er mwyn esbonio i'r cyhoedd ble byddai'r gwaith yn digwydd. Tynnodd swyddogion sylw at y ffaith eu bod yn gweithio'n agos gyda chydweithwyr yn y Tîm Gwasanaethau Cyfathrebu a Digidoli sicrhau bod y negeseuon cywir yn cael eu postio ar y cyfryngau cymdeithasol; bydd y negeseuon hyn yn cynnwys ffotograffau cyn ac ar ôl y gwaith, gan y bydd y rhain yn dangos yn glir pa wahaniaeth y bydd y gwaith yn ei wneud.

Yn dilyn craffu, roedd y pwylgor yn gefnogol o'r cynigion i'w hystyried gan Fwrdd y Cabinet.

Ystyried Cynllun Datblygu Lleol Newydd Castell-nedd Port Talbot

Derbyniodd y Pwyllgor adroddiad i ystyried Cynllun Datblygu Lleol Newydd Castell-nedd Port Talbot 2021-2036, Ymgynghoriad Drafft y Cytundeb Cyflawni ac Ymgynghoriad Drafft yr Arfarniad Cynaliadwyedd Integredig; dyddiad dechrau'r ymgynghoriad arfaethedig oedd 16 Awst 2021, a bydd yn dod i ben chwe wythnos yn ddiweddarach ar 27 Medi 2021.

Hysbyswyd yr aelodau fod Cynllun Datblygu Lleol (CDLI) presennol y cyngor wedi'i fabwysiadu am 15 mlynedd (o 2011 i 2026) ac y bydd angen i'r cyngor adnewyddu'r cynllun hwn bob pedair blynedd; roedd swyddogion wedi cyflwyno adroddiad adolygu ac yn paratoi CDLI newydd, felly pan fydd y cynllun newydd yn cael ei fabwysiadu, byddai'n disodli'r CDLI presennol.

Oherwydd cychwyniad y pandemig, tynnwyd sylw at y ffaith bod rhywfaint o oedi wedi bod yn y broses. Roedd swyddogion wedi ailddechrau gweithio ar y Cytundeb Cyflawni Drafft a oedd yn nodi'r canlynol:

- Yr amserlen – roedd angen llunio'r cynllun o fewn 3.5 mlynedd, ac nid oedd yn rhoi llawer o amser i lunio'r cynllun cynhwysfawr hwn;

- Y cynllun cynnwys y gymuned – roedd hyn yn cynnwys gyda phwy y byddai'r cyngor yn cysylltu, pryd y cysylltir â nhw a sut y cysylltir â nhw;
- Yr adnoddau y bydd Cyngor Castell-nedd Port Talbot yn eu defnyddio i baratoi'r cynllun;
- Y gyllideb ar gyfer llunio'r cynllun o fewn yr amserlen.

Nodwyd bod yr Arfarniad Cynaliadwyedd Integredig (ACI) yn broses ailadroddol ar ffurf adroddiad; roedd angen anfon unrhyw bolisiau neu strategaethau etc. a luniwyd wrth i'r cynllun gael ei baratoi fynd drwy'r broses ACI i'w hasesu. Soniwyd y bydd yr asesiad hwn yn penderfynu a oedd y gwahanol bolisiau dogfennau eraill yn addas i fodloni gofynion cynaliadwyedd y cynllun cyffredinol; os penderfynir nad ydynt yn addas, bydd angen i Swyddogion eu diwygio.

Cyfeiriwyd at gynnwys y gymuned a sut roedd hyn yn allweddol wrth ddatblygu'r CDLI; yn y blynnyddoedd blaenorol, roedd y cyngor wedi anfon taflenni at breswylwyr, ond nid oedd hyn yn llwyddo i'w hannog i ymwneud â'r CDLI. Nododd yr aelodau bwysigrwydd cyrraedd pob etholwr gan ei fod yn ymarfer ymgynghori sylweddol iawn. Gwnaed awgrym yngylch gwella ymgysylltiad y cyhoedd sef bod llythyr yn cael ei lunio mewn ffordd debyg i'r ffordd y cafodd y preswylwyr eu llythyr treth y cyngor, gan mai dyma'r math o wybodaeth y byddai gan y rhan fwyaf o'r cyhoedd ddiddordeb ynddo, ac felly'n byddent yn ei agor a'i ddarllen, ac roedd hefyd yn ffordd llai costus o gael mwy o bobl i ymgysylltu. Nododd swyddogion y sylwadau a wnaed ar gyfer gohebiaeth yn y dyfodol; roedd y tîm bob amser yn chwilio am syniadau newydd, ac os oedd gan yr aelodau unrhyw awgrymiadau pellach, fe'u hanogwyd i gysylltu â'r tîm. Cytunwyd, yn amodol ar gymeradwyaeth, y byddai'r awgrym yn cael ei gynnwys yn yr adroddiad cyn dechrau'r ymgynghoriad.

Cynhaliwyd trafodaeth mewn perthynas â sylwadau ar gyfryngau cymdeithasol. Gofynnwyd a allai'r Tîm Cyfathrebu helpu gyda hyn ac ymateb yn uniongyrchol i sylwadau ar dudalennau cyfryngau cymdeithasol, er mwyn ceisio annog preswylwyr i ymateb i'r ymgynghoriad yn y ffordd gywir; byddai hyn yn helpu i sicrhau na chollir sylwadau defnyddiol, a bod preswylwyr yn cael gwybod am y broses gywir o gyflwyno sylwadau. Cadarnhaodd swyddogion fod deddfwriaeth ar waith mewn perthynas â chyflwyno sylwadau, naill ai drwy ffurflen neu ar y porth ymgynghori; ni ellid derbyn sylwadau/awgrymiadau a wnaed ar gyfryngau cymdeithasol. Nodwyd y byddai angen adnoddau er mwyn monitro sylwadau ar gyfryngau

cymdeithasol ac ni ellid cadarnhau hyn. Tynnodd swyddogion sylw at y ffaith bod angen iddynt ystyried ffyrdd o ymgysylltu â phob grŵp o bobl, gan gynnwys y rheini nad ydynt yn defnyddio'r rhyngrwyd. Soniwyd y byddai'r defnydd o jargon yn cael ei leihau er mwyn sicrhau bod gan y cyhoedd ddealltwriaeth glir o'r hyn yr oedd y cyngor yn ceisio'i gyflawni; Roedd swyddogion yn gweithio gyda chwmni lleol i ailfrandio'r CDLI a chyflwyno fideos a oedd yn symleiddio'r broses ac yn cynnwys pobl. Awgrymwyd y gallai aelodau fod yn rhan o'r gynrychiolaeth ar gyfryngau cymdeithasol i gyfeirio'r cyhoedd i'r cyfeiriad cywir.

Mewn perthynas â'r cyfarfodydd rhanddeiliaid, roedd yr adroddiad a ddosbarthwyd yn nodi y byddai'r cyfarfodydd yn cael eu cynnal ar-lein; Gofynnodd yr aelodau a fyddai'n bosib cynnal cyfarfodydd wyneb yn wyneb pe bai'r cyfyngiadau'n caniatáu hynny, gan y byddai'n dangos pwysigrwydd ac arwyddocâd yr hyn yr oedd y cyngor yn ei wneud. Cadarnhaodd swyddogion, pe bai canllawiau'r Llywodraeth yn newid, y byddent yn gallu cynnal cyfarfodydd wyneb yn wyneb; cytunwyd y byddai Swyddogion yn sicrhau bod hyn yn cael ei egluro yn yr adroddiad a ddosbarthwyd.

Gofynnwyd a oedd modd lobio Llywodraeth Cymru mewn perthynas â datblygu ardaloedd tir llifogydd, gan fod cryn dipyn o dir wedi'i gynnwys yn y categori hwn. Dywedodd swyddogion y byddai llifogydd yn cyfyngu'n fawr ar ddatblygiad y gwaith hwn; roedd Nodyn Cyngor Technegol (TAN) Llywodraeth Cymru ar lifogydd yn cael ei lunio ar hyn o bryd, a disgwyli'r iddo gael ei gyhoeddi fis nesaf i Swyddogion ei ystyried. Nodwyd bod Llywodraeth Cymru yn gweithio gyda Cyfoeth Naturiol Cymru (CNC) i ddatblygu mapiau llifogydd newydd, a fydd o bosib yn cynnwys ardaloedd llifogydd newydd; byddai hyn yn effeithio ar sut y caiff y CDLI ei lunio, ond roedd yr amseru'n dda o ran y cam yr oedd y tîm wrthi'n cyflawni wrth ddatblygu'r cynllun.

Hysbyswyd yr aelodau fod rheoliadau hygyrchedd ar waith, a oedd yn golygu bod yn rhaid i bopeth fod ar gael ar y wefan a'r deunyddiau eraill a ddefnyddir i gyfathrebu â'r cyhoedd; roedd angen i'r negeseuon fod yn ddealladwy, yn glir ac yn gryno. Soniwyd y byddai gan y cyhoedd ddiddordeb mewn rhai o gamau'r CDLI a rhai agweddau arno, yn hytrach na'r holl broses; roedd angen rheoli'r pwyntiau diddordeb penodol hyn yn y broses yn ofalus ac roedd angen i Swyddogion sicrhau bod y negeseuon cywir yn cael eu cyfleo i'r cyhoedd.

Nodwyd bod dichonoldeb yn elfen allweddol o'r CDLI; pan gyflwynodd datblygwyr dir, roedd yn hanfodol eu bod yn dangos sut y byddai'r safle hwnnw'n cael ei ddatblygu, gan ystyried holl ofynion Adran 106 y cyngor. Pan gyflwynwyd tir, dywedodd swyddogion fod angen i dirfeddianwyr/datblygwyr y safle sicrhau bod gofynion Adran 106 yn cael eu hystyried wrth brynu'r tir i sicrhau bod y cyfleusterau hefyd yn cael eu darparu ac wedi'u sefydlu ar gyfer y gymuned; gan gynnwys isadeiledd gwyrdd, teithio llesol etc., i sicrhau ei fod yn lleoliad y mae pobl eisiau byw yn dd.

Aeth y Pwyllgor drwy amserlen y CDLI, yn enwedig yr amserlen ar gyfer cyhoeddi'r gofrestr safleoedd ymgeisiola'r adborth cymunedol ar safleoedd ymgeisiol. Cadarnhawyd y cyhoeddir y gofrestr safleoedd ymgeisiol ym mis Mehefin 2022, ar ôl cyfnod yr etholiad; bydd swyddogion yn adolygu adborth y gymuned, ond ni fyddant yn ymateb iddo gan y byddai hyn yn cymryd cryn dipyn o amser. Ychwanegwyd y bydd y sylwadau'n cael eu hystyried pan gaiff y safleoedd ymgeisiol eu hasesu.

Tynnodd swyddogion sylw at y ffaith y byddent yn hapus i hwyluso unrhyw seminarau ar gyfer yr holl aelodau mewn perthynas ag agweddau amrywiol ar y CDLI, pe bai'r aelodau'n gofyn am hyn.

Cynigiwyd a secondiwyd gwelliant ffurfiol i'r argymhelliaid a gynhwyswyd yn yr adroddiad a ddosbarthwyd, a newidiodd argymhelliaid rhif 1 i'r canlynol:

Cytuno ar gytundeb cyflawni ymgynghoriad drafft y CDLI newydd fel y'i nodir yn atodiad 2 at ddibenion yr ymgynghoriad, yn amodol ar gynnwys yr adborth gan aelodau yn y Pwyllgor Craffu Adfywio a Datblygu Cynaliadwy mewn perthynas â chynnwys y gymuned.

Delivery of Community Benefits in Relation to the Strategic School Improvement Programme and the Welsh Government's 21st Century Schools initiative.

Purpose of the Report:

To provide Members with a report on outputs and results from the delivery of community benefits through the construction phase of Cefn Saeson Comprehensive School.

Executive Summary:

The Council's Strategic School Improvement and Welsh Government's 21st Century Schools programmes aims to provide long-term social, environmental and economic benefits to schools and the wider community. To achieve these wider programme aims, appointed contractors are required to deliver on a range of

community benefits targets which include training and upskilling new workforce entrants, school STEM (science, technology, engineering, mathematics) engagements, support of the local supply chain and wider community in-kind support.

Background:

In 2019 Morgan Sindall were awarded the contract for Cefn Saeson Comprehensive to complete the new build English-medium school for 900 pupils to replace the existing secondary school as part of the Band B 21st Century Schools Programme. The project had a construction value of £27m and commenced in August 2019 for a duration of 151 weeks. Handover of the new school took place in March 2021 and demolition of the existing school and new sport pitches have followed on from that with completion expected in July 2022.

As with all the Council's construction projects, targets were set as part of the contract awarded and the Council's Community Benefits Officer and Project Management team worked closely with the contractor to deliver a range of community benefits. While the pandemic affected the achievement of some of the targets principally the School Engagement and STEM delivery, on all other requirements targets were exceeded. With ten months left on the project plans are being put in place to meet the school engagement and STEM targets and achieve even more outcomes on Targeted Recruitment & Training. Outcomes so far have included supporting into employment apprentices, the long term unemployed, trainees, work experience opportunities for people in education, supporting the local supply chain and local community initiatives.

Some project statistics so far include:

- 29 new entrant jobs (previously unemployed)
- 19 new entrant apprentices

- 2153 person weeks of new entrant jobs
- 1657 weeks of new entrant training (graduates, work & pupil placements)
- 40% of labour force from SA postcodes
- 99% of labour force from Wales
- £23.5 million total value of contracts awarded so far with 61% of those contracts awarded to South West Wales businesses

The contractor has worked with Port Talbot Women's Aid social enterprise arm, Thrive, from the beginning, using their mobile catering unit to feed workers on site and as with the Council's other construction projects employ cleaners from their cleaning enterprise. They have also used local contractors on site for scaffolding, steelwork and office furniture and held a Meet the Buyer event at the Gwyn Hall to encourage local suppliers to tender.



The pandemic has affected levels of community engagement however the contractor has made a financial contribution to Neath Community Tennis Courts to assist with improvement works and have agreed to support Bspoked Enterprises, the Council's Adult Learning Disability Centre in converting offices into an independent living facility.



To see the whole range of community benefits achieved on the project and to read individual case studies Morgan Sindall produced a booklet on the social value story on Cefn Saeson so far which can be viewed in the appendix below.

The Council currently has nine major construction projects underway, including Neath Abbey Primary, YGG Ystalyfera, Harbourside Strategic Employment Site and The Technology Centre on Baglan Bay Energy Park and all are subject to community benefits outputs.

Ian Thomas Construction, a company on the South West Wales framework have been awarded the groundworks package and secured two and a half years work for their operatives in Neath Port Talbot.






Exciting opportunity for gap year student

Morgan Sindall supported the Jobs Fair at Hillside Secure Children's Home by providing career advice and discussing potential future opportunities.



Local company win contract for providing site accommodation

Local company Wernick were awarded the contract for provision of all site accommodation on site. This large contract helped create new job opportunities and secure existing ones within the local authority.



Long Term Unemployed Returns to work

Phil Parry is from the Neath area and has been unemployed for 15 years. Phil was taken on as part of the team at Cefn Saeson for 132 weeks. On completion we will work with Phil to identify other opportunities on our projects.



Employment opportunity for local resident

Local resident Anthony was taken on and trained as a Gatekeeper for the duration of the project. We are in the process of working with Anthony to identify further alternative opportunities on our other schemes.



Partnering with Ministry of Furniture

We employed the services of this local firm to fit out our office at Cefn Saeson. All furniture is 2nd hand and recycled/refurbished at their factory so is a great sustainable alternative to procuring new.



Career changers get a superb opportunity

Partnering with Career Changers we identified opportunities for unemployed Shannon Jones who was offered training and employment as a labourer – with the opportunity to work towards a plant operator apprentice. Morgan Sindall supported her off-site training and paid her the living wage whilst getting qualified.





Collaborating with Thrive Women's Aid

We collaborated with Thrive Women's aid based in NPT and employed Lisa to join the team as a cleaner. She made a fantastic addition to the team and is a great example of how this project has benefitted the lives of local residents.

Roller qualification for Shannon

Career changer Shannon has gone from being unemployed to becoming a labourer after just 4 months on-site. She has additionally been supported for further training and has recently gained her roller qualification.



Local scaffolding firm secure large package of works

We employed the services of local firm Rowecord Total Access to undertake all the scaffold works on the project. A lot of their staff live within the local authority which in turn will enable new opportunities within the local area.





Milestone steel signing event

We hosted a steel signing event to mark the start of the steel frame works for the school. The headteacher, head girl and boy attended and each signed the frame. The event offered the opportunity to discuss construction careers with the pupils and further collaboration opportunities with the school.



New Document Controller joins the team



Previously unemployed Carmen joined our team to cover maternity leave for Melissa Wines. At the end of her term we will look to offer her a permanent role on the project.



Construct IT event held

We delivered our award winning Construct IT challenge to Year 8 pupils during the school PSE careers day. In total this was delivered to 152 pupils throughout the day and offers the pupils a great insight into construction planning.



TR&T launch held with key stakeholders

Morgan Sindall and NPT hosted a joint workshop to emphasise the importance of TR&T on the project and leaving a legacy within the community. This collaborative workshop offered a fantastic opportunity for the supply chain to meet the people that will help them to deliver their contractual TR&T requirements. 
Pembroke Recovery Centre and Care Village

It is hoped that this newly created opportunity will support Thrives goal to create more opportunities for the people they support. Our workforce were encouraged to utilise this service in an attempt to keep people on-site and avoid going out into the community in light of the Covid 19 global situation.



New opportunity created with Thrive

The team at Cefn Saeson worked with Thrive to create a new paid job opportunity for Jess as an on-site cleaner. Jess currently resides in The Women's refuge in Port Talbot and is doing a distance learning college course. Jess fulfilled a critical role of keeping the offices and welfare clean and sanitised. We're hopefull her experience with us will form a foundation for her future plans.
