Some concerns have been raised regarding older persons and how the lighting might affect house calls during the night. The pilot will help explore this issues.

					however this limited pilot is to help inform a fuller assessment. Some concerns have been raised regarding effects on the mobility of those with disabilities. The pilot will help explore this issues.

The charity “Thrive Woman’s Aid” have however raised concerns regarding the removal of lighting in the small hours and that there may be greater impacts on women. The pilot will help explore any sex related issues. Consultation with the Police, Thrive Woman’s Aid, and the Community Safety Team will be ongoing as part of the trial

Although, removing light pollution from locations would likely have a positive impact as opposed to a negative one on local wildlife.
To promote the resilience of ecosystems, i.e. supporting protection of the wider environment, such as air quality, flood alleviation, etc.		X				Part night lighting would reduce light pollution during periods when the lighting is switched off.

Long term - how the initiative supports the long term well-being of people	X		Part night lighting will reduce financial risk and make street lighting more resilient/sustainable in the context of future energy increases. Also, as we move to a low carbon future, the initiatives would reduce energy demand in the evening when renewal energy such as solar is not available. This pilot would provide valuable insight into the affects and sustainability of a permanent part night lighting regime.
Integration - how the initiative impacts upon our wellbeing objectives	X		The initiative would assist moving to a low carbon future. Impacts in relation to crime and fear of crime generally, or the effects on those with protected characteristics such as older people, need more detailed assessment should the Council wish to implement part night lighting permanently, which the pilot will assist with.
Involvement - how people have been involved in developing the initiative	X		Some formal public consultation on street lighting energy and associated measure has been undertaken and results presented to Members. To date there has been a mixed response from the public regarding part-night lighting.
Collaboration - how we have worked with other services/organisations to find shared sustainable solutions	X		Consultees have included the Police, the Community Safety and Road Safety Team and Thrive Woman's Aid. These consultations will be ongoing through the pilot along with local residents.
Prevention - how the initiative will prevent problems occurring or getting worse	X		The more energy public lighting uses, and the more fossil fuel based energy in particular, the greater the future financial and environmental risks. Consultation responses have indicated concerns that part night lighting may lead to greater antisocial behaviour/crime/fear of crime, which the pilot exercise will assist with exploring. It is noted that Section 17 of the Crime and Disorder Act 1998 states that all relevant authorities – which includes Neath Port Talbot Council – have a duty to consider the impact of all their functions and decisions on crime and disorder in their local area.

			This pilot will assist in fulfilling this general duty. As above, consultation with the Police, Thrive Woman's Aid, and the Community Safety Team will be ongoing as part of the trial alongside consultation with residents, and the trial at any particular location can be stopped at any time should that become necessary. Some general comfort can be taken from the fact that 7 of the 22 Local Authorities in Wales are already successfully implementing Part Night Lighting.

Reasons for this conclusion	
There is a need to explore in further detail any potential impacts on older people, people with disabilities and women. It is noted part-night lighting will have a positive impact on energy usage, financial risk and service sustainability, whilst it is hoped providing little or no adverse impact on service users including those with protected characteristics. There may be also be a wildlife benefit when lights are off.
