Two waves of consultation have been undertaken with the local community, local members and Council Officers in relation to the proposals.

Consultation Wave 1 consisted of meetings with local Members, Cabinet Members and Officers in addition to an online public questionnaire (444 respondents) and face to face drop-in sessions (attended by 236 people) held over two days at Aberafan Leisure and Fitness Centre on 16<sup>th</sup> and 17<sup>th</sup> February 2024. This wave of research focused on what improvements/ investments were needed on the Seafront in order to better cater for the needs of residents and visitors.

Consultation Wave 2 consisted of meetings with local Members, Cabinet Members and Officers in addition to an online public questionnaire (622 respondents) and face to face drop-in sessions (attended by 254 people) held over two days at Aberafan Leisure and Fitness Centre on 18<sup>th</sup> and 19<sup>th</sup> October 2024. This wave of the research focused on feedback on the draft proposals put forward for inclusion within the Masterplan.
