# CHANGES TO STRUCTURE OF EARLY YEARS/ FAMILY INFORMATION SERVICE TEAM

### 1. Purpose of the Report

To seek Members approval to make changes to the structure of the Early Years/Family Information Service Team and the creation of one new post, Family Information Service Out of School Childcare Support Assistant, within the Think Family Partnership.

## 2. Background

The Early Years/ Family Information Service Team is responsible for the statutory duties laid out in Childcare Act 2006 which include the duty to ensure there is sufficient childcare for working parents, undertake a Childcare Sufficiency Assessment (CSA) every three years and to provide a comprehensive information service for families, along with providing information, advice and assistance to childcare providers in the county.

An identified gap in the CSA was to promote the work of the Family Information Service so that parents and carers could find information on childcare including out of school childcare.

It has been proposed that the Out Of School Childcare Grant could be utilised to help fill the identified gap by funding a temporary Family Information Service Out of School Childcare Support Assistant to take responsibility for outreach work to promote out of school childcare including where to find OOSC services and also financial support to access such services.

The Out of School Childcare Grant is funding from Welsh Government to improve access to financial support for wrap-around childcare, holiday and play provision and is the responsibility of the Early Years Team. Quality wrap-around childcare is essential to help support parents access work and training.

Welsh Government approved the proposal of this grant on 13<sup>th</sup> May 2015, see Appendix 3.

The addition to the team will enable face to face contact with the public and professionals who work with families throughout the county borough all year through attending events, school activities and to target hard to reach families in isolated communities.

It is proposed that the Family Information Service Web and Development Officer take line management responsibility of this new post and also line manage the existing Family Information Service Support Assistant to ensure work is co-ordinated and reflects the needs of the service.

### 3. Financial Appraisal

The proposed model will be fully funded by the Out Of School Childcare Grant provided by Welsh Government and managed by the Think Family Partnership, see Appendix 2 attached.

# 4. Reason for Proposed Decision

- 1. To ensure that the Family Information Service and information regarding out of school childcare is promoted to families within the county, as identified as a need in the Childcare Sufficiency Assessment.
- 2. To ensure the work of the Family Information Service is co-ordinated and reflects the needs of the service, families and professionals who work with families.

# 5. Recommendations

It is recommended that Members APPROVE:

- 1. The creation of a temporary post, Family Information Service Out of School Childcare Support Assistant, utilising the Out of School Childcare Grant Funding secured until 31<sup>st</sup> March 2016.
- 2. That line management responsibility for the current Family Information Service Support Assistant moves to Family Information Service Web and Data Development Officer.


