7. **URGENT ITEM**

Because of the need to deal now with the matter contained in Minute No 8 below, the Chairperson agreed that it could be raised as today's meeting as an urgent item pursuant to Section 100B (4) (b) of the Local Government Act 1972.

Reason

As this is the first meeting following the announcement made by Tata Steel.

8. TATA STEEL

The Chief Executive made the following statement on behalf of the Council following the announcement made by Tata Steel:-

"The Council deeply regrets the decision of Tata's main Board last evening not to endorse the proposed turnaround plan. On the other hand, it is a relatively positive development that the prospect of immediate total closure appears to have been averted.

The Council remains committed to working with all levels of government and others, including the trade unions and local business, to safeguard as many jobs as possible at the Port Talbot works and further afield as well as in the extensive supply chain and the wider economy.

The Council has already played a full part in the task force established by the Welsh Government following the announcement of job losses in January of this year and is in regular contact with the management at Tata in Port Talbot. We have, for example, been instrumental in developing detailed proposals for a proposed Enterprise Zone in Port Talbot.

The Council is aware of press reports this morning that amongst other options, a management/employee buy-out is being considered with government support, possibly including temporary nationalisation. We welcome that development and any alternative third party involvement that will preserve the future of steel making in Port Talbot and Wales.

However, time is of the essence. All the indications are that we don't have much as it would appear that Tata is not prepared to carry on underwriting the business for a lengthy period. Government and other parties therefore need to move very quickly to put substance behind any realistic options for the future of the strip products division.

It is also imperative that the assets at Port Talbot and elsewhere in the UK are preserved and protected to ensure that any sale or buy out option has the best possible chance of success in what remains a difficult market. Steel is a foundation industry of strategic importance to both the UK and Welsh economies. We therefore need specific proposals to come forward quickly with government support including a package of measures to alleviate the financial pressures on the sector. These have been well-documented – for example, uncompetitive energy costs. Short term, we need quick decisions to help companies in the supply chain and the sign off of the Swansea Bay Tidal Lagoon is the most obvious case in point. Longer term, we need to progress greater economic resilience for the region as set out in the City Region's City Deal proposal last month.

The consequences of failure for the area and the wider South Wales economy hardly need to be spelt out with the prospect of some 10,000 jobs now at risk – for every 1 job at Tata there are at least 3 in the supply chain and the wider economy. It is therefore imperative that all parties move on from rhetoric to specific and detailed analysis of the options available and what needs to be done to save steel making.

No stone must be left unturned and the Council stands ready to play its part. Time is short - tea and sympathy is not enough and blame games are equally unproductive."
