### SUMMARY OF WELSH GOVERNMENT GRANT APPROVALS RECEIVED FOR HIGHWAY AND TRANSPORT 2016/2017

#### Purpose of Report

1. To inform Members of Welsh Government grant approvals received for Highway and Transport related schemes for the financial year 2016/2017.

2. To inform Members of the Welsh Government grant allocation for Highway and Transport related schemes for 2016/2017.

#### Background

- 3. On 23rd March 2016, the Welsh Government announced grant approvals received for Highway and Transport related schemes for the financial year 2016/2017 to the total value of £2,877,816.
- 4. The funding is allocated as follows:-

Local Transport Fund including Active Travel of up to £2,076,00. Road Safety Capital of up to £324,000. Road Safety Revenue of up to £77,816. Safe routes in Communities of up to £400,000

8. All of the funding has to be claimed in full by 30th April 2017, otherwise any unclaimed funding will no longer be available.

# Legal Impacts

11. The Integrated Transport Hub is the subject to a Planning Application and a statutory stopping up order of the highway.

## **Risk Management**

- 12. All the funding has to be claimed in full by 30th April 2017, otherwise any unclaimed funding will no longer be available.
- 13. The Integrated Transport Hub (£1,120k) is match funding, a bid has been made to WEFO for (£2,560k) if this bid is unsuccessful the scheme will be unable to progress. The first part of the WEFO bid application has been approved; the second part has been submitted and is subject to final approval.
- 14. A planning application has been submitted for the Integrated Transport Hub, however, there are issues with the Flood Consequences Assessment (FCA) and approval from Natural Resources Wales (NRW) a revised FCA has been submitted to the NRW the outcome of which is awaited before planning approval is granted.

- 16. It should be noted that the LTF projects feature in the approved Local Transport Plan 2015-2020.
