#### **Matter for Decision**

#### **Proposed Traffic Orders**

#### **Individual Disabled Parking Places**

#### **Purpose of Report**

- 1 To obtain Members' approval to advertise the Legal Orders for the implementation of Traffic Orders for the following individual disabled parking places:-
  - No. 15 Bwlch Crescent, Cimla, Neath, SA11 3RY
  - No. 21 Penbryn Road, Skewen, SA10 6US
  - No. 5 Jac y Ddu Road, Briton Ferry, Neath, SA11 2LT

#### **Executive Summary**

- 2 The report outlines the proposed Order and the reason why the Order is required.

- 3 The above applicants have satisfied the Council's criteria for an individual disabled parking bay.

#### **Financial Impact**

- 4 The work will be funded through the Capital Programme.

No. 5 Jac y Ddu Road, Briton Ferry, Neath, SA11 2LT: approval is given for the proposed measures to be advertised, as indicated on the attached plan (Appendix C) and for the Order to be implemented, subject to there being no objections.
