# **Purpose of the Report**

The purpose of this report is to seek permission to consult on the NPT Welsh in Education Strategic Plan (WESP) 2017-2020..

# **Executive Summary**

Members are asked to give permission for the draft Welsh in Education Strategic Plan (WESP) to be consulted upon. The draft will be sent to a range of consultees including the Early Years Development and Childcare Partnership: the WESP Forum; all NPT school councils; Estyn; the Children's Commissioner; and the Welsh Language Commissioner.

#### **Background**

The draft Welsh in Education Strategic Plan (WESP) details how the authority plans to contribute towards the Welsh Government's aim of achieving one million Welsh speakers by 2050.

It forms part of the Council's broad strategy for the Welsh Language and contains an action plan for the development of Welsh education in NPT

The first WESP was published in 2012: this document describes progress to implement the initial plan and actions for the future.
